

ORDER GRANTING MOTION TO INTERVENE

By motion dated May 31, 1994, an entity known as the EBDC/ETU Task Force, composed of four companies (BASF Corporation, E. I. du Pont de Nemours & Co., Inc., Elf Atochem North America, Inc., and Rohm and Haas Company) moved for leave to intervene in this proceeding to determine whether the Final Cancellation Order for Pesticide Products Containing EBDCs should be modified in certain respects.

The motion states that the task force members "jointly developed the data required by EPA to reregister pesticide products containing EBDCs and which data EPA relied upon in developing the Cancellation Order." Further, "(E)ach member of the EBDC/ETU Task Force owns one or more EBDC registrations, and consequently, stands to be directly affected by the proposed modification of the Cancellation Order." It is also stated that the Task Force will "raise only matters pertinent to and not unreasonably broaden the issues already presented."

There being no opposition from respondent EPA or from petitioner Elf Atochem North America, Inc.,<sup>1</sup> and the requirements of the rules of practice pertaining to motions to intervene having been met by the movant, it is hereby ordered that the motion shall be, and it is hereby, granted.
