**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purpose of this amendment is to replace a corrupted drawing from the Amendment #0004 CD, and to revise language in section 33 11 00 of the Construction drawings and specifications regarding the potable water supply line to the treatment building. The revised language is as follows: The new potable water supply line from the tap off of the existing 6" main to the new treatment building shown on drawings C-4 and M-6 as 3" PVC shall instead be 4" ductile iron installed per the City of Grand Island requirements. The Contractor shall coordinate with the City of Grand Island to tap the existing water main.

Except as provided herein, all terms and conditions of the document referenced in item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
