5. a. Purchase Limitation:

Any purchase order placed under this Agreement shall not exceed the limit of the Ordering Officer’s authority as specified herein. The total amount of orders placed against this Agreement shall not exceed \$3,000,000 throughout effective date of this Agreement. Additionally, the total amount of each purchase order placed against this Agreement shall not exceed \$3,000,000.

b. Limitation of Funds:

The contractor shall notify the Contracting Officer in writing whenever it has reason to believe that a purchase order placed against the BPA will exceed 75% of the total “not to exceed amount” listed in paragraph 4(a) of the BPA entitled “Purchase Limitations.”
