FY05 Registration Activity- New Uses

New Uses

- Approved 164 new uses (associated with 702 crops) of 32 previously registered conventional active ingredients
- 27 Reduced Risk new uses, 45 OP alternative new uses
- Approved 8 new uses of previously registered antimicrobial active ingredients

Inert Ingredients Status Update

Status of Exemption Petitions (PRIA)

- 17 completed in FY'05
- 32 pending, including those received in FY05
- 22-25 scheduled for FY06

Status of Exemption Reassessment (FQPA)

- 168 reassessments completed in FY05
- 285 remain to be reassessed



PRIA- Program Performance

Since the start of PRIA:

- 2850 total PRIA submissions
- 1512 completed
- >99% have been completed by PRIA goal
- 18 “not grant” decisions (<1% of total submissions)
- 144 actions with negotiated due dates (5% of total submissions)



PRIA- Program Performance

“Not Grant” decisions:

AD = 0	(total actions=461)
BPPD = 13	(total actions=258)
RD = 5	(total actions=2131)



PRIA- Program Performance

Actions with negotiated due dates:

AD = 43	(total actions=461)
BPPD = 50	(total actions=258)
RD = 51	(total actions=2131)



Pending PRIA Actions

New Active Ingredients

- 21 conventional new active ingredients
 - 13 a.i.'s requesting domestic registration
 - 8 a.i.'s requesting import tolerance only
- 22 biopesticide new active ingredients
- 10 antimicrobial new active ingredients
- PRIA goal expected to be met in all cases- most new a.i.'s scheduled for completion prior to PRIA goal
