FY 05 Registration Activity

Program Goal: 26 New Active Ingredients

12 conventional chemical pesticides

12 biopesticides

2 antimicrobial pesticides



FY05 Registration Activity

New Active Ingredients- 8 Approved

- 2 Conventional Pesticides

FY05 Registration Activity- New Uses

New Uses

- Approved 55 new uses (associated with 280 crops) of previously registered conventional active ingredients
- Approved 4 new uses of previously registered antimicrobial active ingredients
- Approved 3 new uses of previously registered biopesticide active ingredients.



FY05 Section 18 Activity (through 2nd Quarter of FY '05)

Soybean Rust Fungicides

- Extensive Investment by EPA to Help Prepare Soybean Industry with Cleared Fungicides
- Disease Confirmed in Continental U.S. in November 2004
- 19 End Use Products (sec. 3 plus sec. 18) Now Carry SBR Claim
- Section 18's Approved Across 32 States

- Fast Track Amendments 1414
- Non-fast Track Amendments 312
- Fast Track New Products 69
- Non-fast Track New Products 391



Inert Ingredients Status Update

Status of Exemption Petitions (PRIA)

- 22 scheduled for FY'05
- 3 Final Rules published
- 6 nearing completion
- By end of FY05, # of pending petitions will have been reduced from 45 to 25

Status of Exemption Reassessment (FQPA)

- 453 exemptions to be reassessed as of Oct. 1, 2004
- 58 reassessments completed to-date
- 392 remain to be reassessed



PRIA- Program Performance

Since the start of PRIA:

- 2170 total submissions under PRIA
- 892 completed
- >99% have been completed by PRIA goal
- 15 “not grant” decisions (<1% of total submissions)
- 68 actions with negotiated due dates (3% of total submissions)



PRIA- Program Performance

“Not Grant” decisions:

AD = 0

BPPD = 12

RD = 3



PRIA- Program Performance

Actions with negotiated due dates:

AD = 18

BPPD = 28

RD = 26



Pending PRIA Actions

New Active Ingredients

- 28 conventional new active ingredients
 - 17 a.i.'s requesting domestic registration
 - 11 a.i.'s requesting import tolerance only
- 28 biopesticide new active ingredients
- 12 antimicrobial new active ingredients
- Most new active ingredients are scheduled for completion prior to their PRIA goals

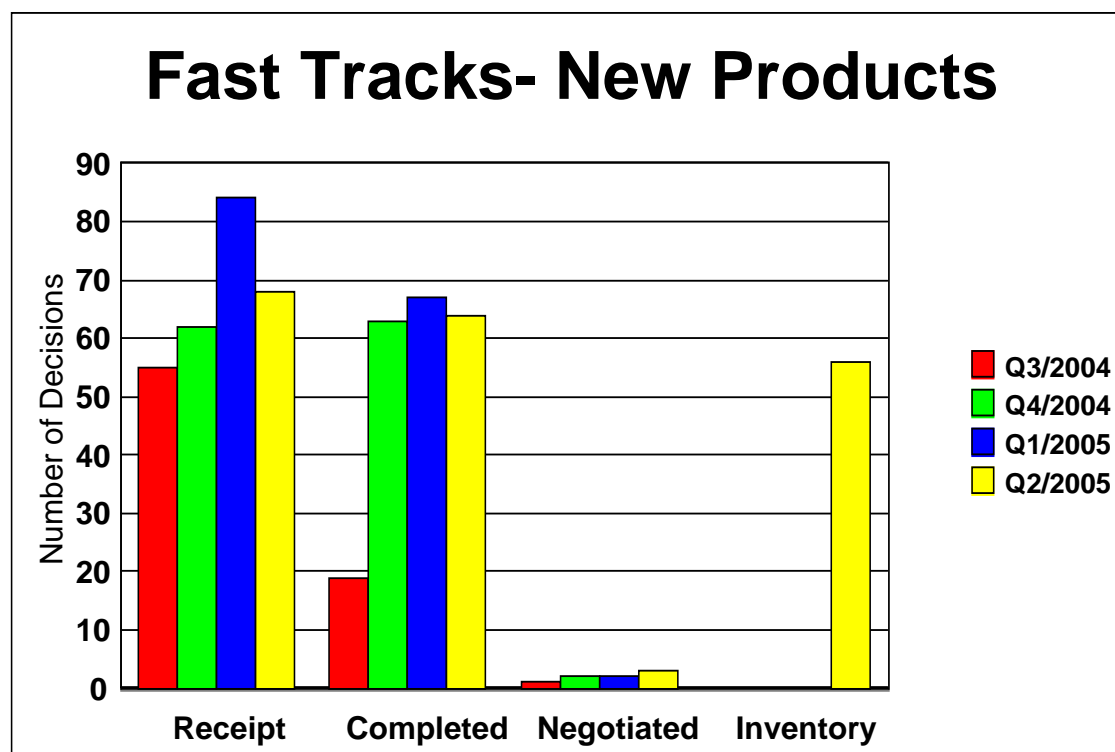


PRIA: 1 Year Later- Fast Track

- 269 received
- 213 completed
- 8 negotiated
- 56 pending

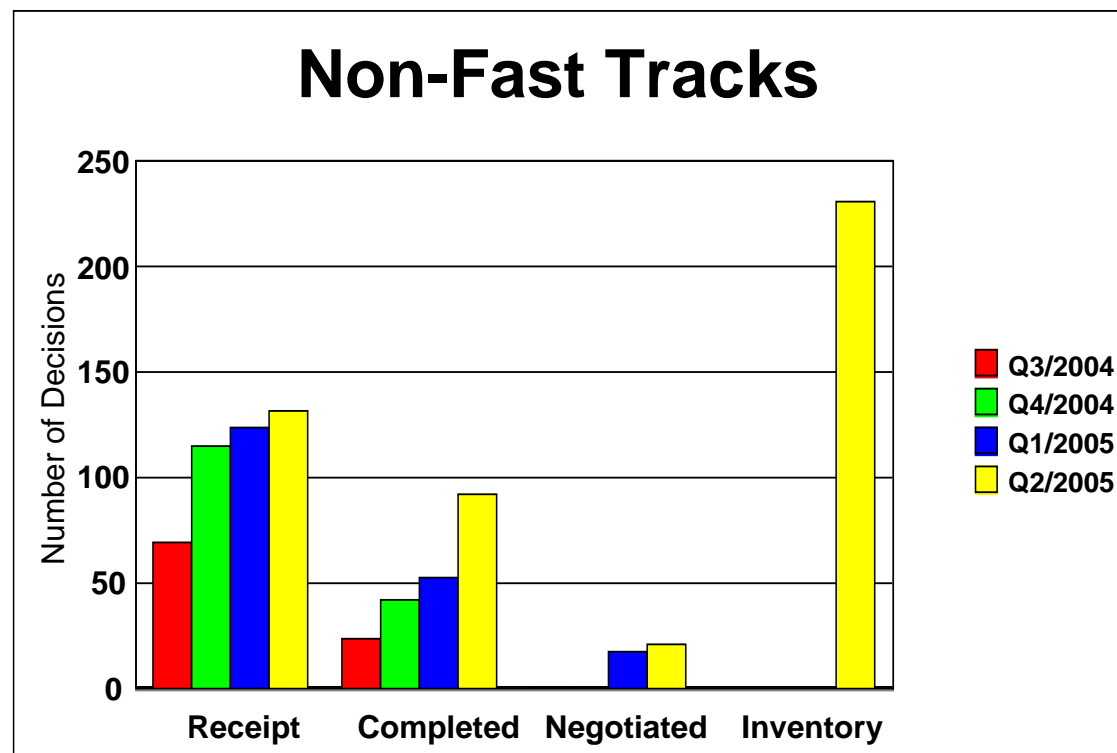


PRIA: 1 Year Later- NFT

(PRIA goal: 6-24 months)

Totals:

- 440 received
- 209 completed
- 38 negotiated
- 231 pending



PRIA: 1 Year Later- NFTA

(PRIA goal: 4-20 months)

Totals:

- 316 received
- 193 completed
- 9 negotiated
- 123 pending
