FY07 Registration Activity

New Active Ingredients

5 Conventional Pesticides

- alpha-Chlorohydrin
- Orthosulfamuron
- Prothioconazole
- Fluopicolide (import tolerance only)
- Metaflumizone (BAS 320I)



FY07 Registration Activity- New A.Is (cont'd)

New Active Ingredients

- 6 Biopesticides
 - Bt Modified Cry3A in corn
 - *Beauveria bassiana* strain HF23
 - Codling moth/leaf roller pheromones
 - Z-9-Tetradecen-1-yl Acetate
 - Z-11-Tetradecen-1-ol
 - Z-11-Tetradecenal
 - Balsam Fir Oil



FY07 Registration Activity- New A.Is (cont'd); FY07 Activity

New Active Ingredients (cont'd)

- 3 Antimicrobials
 - Polymeric betaine
 - Econea
 - T-99



FY07 Registration Activity- New Uses

New Uses

- Approved 75 new uses (associated with 243 crops) of 27 previously registered conventional active ingredients
- 1 Reduced Risk new use, 1 OP alternative new use
- Approved 6 new uses of previously registered antimicrobial active ingredients

Fast Track/Non-fast Track Decisions (PRIA and non-PRIA actions)

- Fast Track Amendments (non-PRIA) 678
 - (RD=546, AD=386, BPPD=46)
- Non-fast Track Amendments 234
 - (RD=141, AD=81, BPPD=12)
- Fast Track New Products 245
 - (RD=186, AD=54, BPPD=5)
- Non-fast Track New Products 318
 - (RD=235, AD=61, BPPD=22)



Inert Ingredients Status Update

Status of Exemption Petitions (PRIA)

- 5 completed in FY'07
- 9 petitions received in FY'07
- 10 petitions pending at EPA
- 6 petitions withdrawn
- 5 petitions in OGC review



PRIA- Program Performance

Since the start of PRIA (*as of 05/02/07*):

- 5081 total PRIA submissions
- 3811 completed
- >99% have been completed by PRIA goal
- 29 “not grant” decisions (<1% of total submissions)
- 518 actions with negotiated due dates (10% of total submissions)



PRIA- Program Performance

“Not Grant” decisions:

AD = 1	(total actions=876)
BPPD = 16	(total actions=448)
RD = 12	(total actions=3757)



PRIA- Program Performance

Actions with negotiated due dates:

AD = 181 (total actions=876)

BPPD = 136 (total actions=448)

RD = 201 (total actions=3757)



Pending PRIA Actions

New Active Ingredients

- 22 conventional new active ingredients
 - 20 a.i.'s requesting domestic registration
 - 1 a.i. requesting import tolerance only
- 19 biopesticide new active ingredients
- 8 antimicrobial new active ingredients
- PRIA goal expected to be met in all cases- most new a.i.'s scheduled for completion prior to PRIA goal
