FY08 Registration Activity

New Active Ingredients

6 Conventional Pesticides (1 withdrawn)

- Iodomethane (Methyl Bromide Alternative)
- Mandipropamid (Reduced Risk)
- Pyroxsulam
- Chlorantraniliprole (Reduced Risk)(Global Review)
- Pyridalyl (OP Alternative)



FY08 Registration Activity- New A.Is (cont'd)

New Active Ingredients Biopesticides

- Fox Urine
- Calcium lactate
- Extract of *Chenopodium ambrosioides*
- *Bacillus firmus*

New Active Ingredients (cont'd)

Antimicrobial

- Tolyfluanid
- Silver Sulfate



FY08 Registration Activity- New Uses

New Uses

- Approved 201 new uses of 51 previously registered conventional active ingredients
- 2 conventional Reduced Risk new uses
- Approved 12 new uses of one previously registered biopesticide active ingredient
- Approved 15 new uses of 9 previously registered antimicrobial active ingredients

Fast Track/Non-fast Track Decisions (PRIA and non-PRIA actions)

- Fast Track Amendments (non-PRIA) 1256
 - (RD=899 AD=267, BPPD=90)
- Non-fast Track Amendments 251
 - (RD=156, AD=81, BPPD=14)
- Fast Track New Products 250
 - (RD=194, AD=47, BPPD=9)
- Non-fast Track New Products 302
 - (RD=228, AD=42, BPPD=32)



Inert Ingredients Status Update

Status of Exemption Petitions (PRIA)

- 10 completed in FY'08
- 9 petitions received in FY'08
- 35 petitions pending at EPA
- 11 Non-food Use Requests in FY'08
- 3 petitions in OGC review



PRIA- Program Performance

Since the start of PRIA (*as of 5/15/08*):

- 6865 total PRIA submissions
- 5810 completed
- >99% have been completed by PRIA goal
- 44 “not grant” decisions (<1% of total submissions)
- 926 actions with negotiated due dates (14% of total submissions)



PRIA- Program Performance

“Not Grant” decisions:

AD = 9 (total actions=1244)

BPPD = 21 (total actions=594)

RD = 14 (total actions=5027)



PRIA- Program Performance

Actions with negotiated due dates:

AD = 278 (total actions=1244)

BPPD = 194 (total actions=594)

RD = 454 (total actions=5027)



Pending PRIA Actions

New Active Ingredients

- 12 conventional new active ingredients
- 15 biopesticide new active ingredients
- 5 antimicrobial new active ingredients
- PRIA goal expected to be met in all cases- most new a.i.'s scheduled for completion prior to PRIA goal
