## **Current Progress at the Site**

---

On November 6, 2007, the United States Environmental Protection Agency (EPA) and the Virginia Department of Environmental Quality (VADEQ) conducted an environmental assessment site visit at the Atlantic Bulk Carrier (ABC) Corporation. The site visit was a follow up to the file review conducted by Tetra Tech EC, Inc. on behalf of EPA and VADEQ in June of 2007 at the EPA Region III Philadelphia Office and the VADEQ Central Office in Richmond, Virginia. Findings of the file reviews and site visit are documented in the June 6, 2008 Final RCRA Site Visit Report prepared by Tetra Tech EC, Inc. on behalf of EPA and VADEQ. Based on the findings of the file reviews and site visit, ten Solid Waste Management Units (SWMUs) and areas of concern (AOCs) were identified. Upon EPA's evaluation of the findings of the site visit, EPA will determine whether additional information or sampling is required to determine if the environmental indicators have been met or if corrective action is required at the facility.

## **Site Description**

---

In 1977, Chemical Carrier Corporation (CCC) of Virginia began operating as a truck leasing company. In 1981, CCC changed operation as New Dixie Transportation and changed the company name to the ABC Corporation. The ABC Corporation is located at 1902 Roxbury Road in Roxbury, Virginia, 23140, on 18 acres. The property is bordered on the north by CSX railroad track, to the south and east by woodlands/wetlands, and to the west by Route 106. An office building is located on 4 acres adjacent to the 18 acre parcel the ABC Corporation operates a 138 tractor and 385 tank trailer fleet trucking company. The trucking company transports liquid and dry bulk chemicals (virgin raw materials) from manufacturers and suppliers to end users or customers' facilities. The bulk chemicals are used for various end products. Approximately 150 employees are employed by the trucking company that consists of a maintenance building; where trucks and trailers are serviced and maintained, fuel storage tank, and fueling station.
