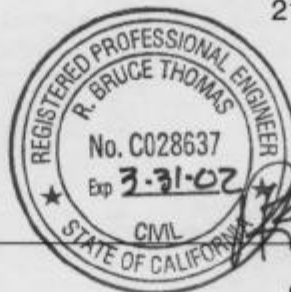

# 1 INTRODUCTION

This summary report has been prepared by Kennedy/Jenks Consultants (Kennedy/Jenks) on behalf of Shell Oil Company, Shell Oil Products Company, and Equilon Enterprises LLC (Shell) as required by joint agency requirements contained in Attachment A, Scope of Work (SOW), Task 4 to the Los Angeles Regional Water Quality Control Board (LARWQCB) Stipulated Agreement No. 00-064 and the United States Environmental Protection Agency (USEPA) Administrative Order on Consent USEPA Docket No. RCRA 7003-09-2000-003 (SA/AOC).

Task 4 is entitled, "Interim Provision of Drinking Water Information Summary Report." The overall purpose of this task is to provide data necessary to effectively and thoroughly evaluate the options for interim provision of drinking water. The report summarizes information relevant to the analysis of options for the provision of drinking water.

## 1.1 Sources of Information

As required by the SOW, the information obtained for the preparation of this report came from various publicly available sources, such as agency files, data obtained by Kennedy/Jenks during pilot tests previously conducted at the Charnock facility, and information provided by Southern California Water Company (SCWC), the City of Santa Monica (COSM) and the US EPA. The facilities were not physically inspected to prepare this report. Information regarding potential impacts of contamination and of possible facility modifications to the COSM and SCWC water systems is an engineering estimate that is based on Kennedy/Jenks field studies and evaluations.

Environ International Corporation (Environ) provided the information for compliance with the California Department of Health Services (DHS) memo dated 5 November 1997 entitled, "Policy Memo 97-005, Policy Guidance for Direct Domestic Use of Extremely Impaired Sources." The Source Water Assessment and the Raw Water Quality Characterization information are contained in Appendices P and Q respectively, to this report but are separate stand-alone documents and will be submitted under separate cover by Environ.
