Attention Students, Teachers, Parents and School Administrators!

The U.S. Environmental Protection Agency, Region 8, would like to invite your students to participate in the 2011 Earth Day “What Makes a School Green Art Challenge.”

The contest will ask students to draw or design “what makes their school green or what could make their school green”. Students can design a green school, draw green school activities or draw what makes their school green already. Example green activities include: recycling, planting trees, changing light bulbs, etc. Teachers and parents can utilize the numerous links provided below for additional information and teaching materials about Green and Healthy Schools.

The purpose of the contest is to see what school children think will make their school green or greener! The drawings will be very educational for EPA, teachers and parents as they will show us what our children think about environmental protection and environmental health and safety in the school environment.

The winners will be chosen based on the most creative and representative drawings/design of green schools and/or green school activities. The drawings will be featured on the R8 web site and in the R8 EPA green office building in Denver, Colorado. A certificate will be awarded to the winning students and schools. Winning schools and students may be able to participate in regional green school communications, workshops, social media outlets and additional recognition opportunities.

Follow these simple rules to participate in the challenge:

- The challenge is for students in grades 6-12.
- Entries must be no larger than 22 inches X 28 inches.
- Entries can be either a drawing of green school features/activities or a design of a green school building.
- Please indicate student’s name and school on the back of every entry.**
