Executive Oversight

Institutionalizing Open Government within the Agency:

- To ensure Open Government becomes a part of normal agency operations, the executive oversight function was transferred to an existing executive body, the Quality and Information Council (QIC)
- From the QIC Charter:
 - “The purpose of the QIC is to advise and assist the Assistant Administrator for Environmental Information/Chief Information Officer (CIO) in developing and implementing the Agency’s quality and information goals and polices. The QIC provides the mechanism through which senior Agency officials raise and debate strategic information issues facing the Agency. It offers the CIO direct access to those officials to obtain their counsel on, and commitment to, quality and information strategies and polices.”

Strategic Data Action Plan (SDAP)

Developing a Plan for Greater Accessibility to EPA’s Data and Information:

- The primary purpose of the Strategic Data Action Plan (SDAP) is to standardize and streamline the process of prioritizing and publishing high-value information for public consumption
- Over the last quarter EPA has taken the following actions in support of the SDAP:
 - Formed a project team
 - Defined the scope of the SDAP effort
 - Created an annotated outline of the SDAP with anticipated products, milestones and dates
 - The SDAP Annotated Outline is currently under executive review, and we anticipate it will be published and available to the public in the coming weeks

EPA’s GeoData Gateway Goes Public!

- EPA’s geospatial data and metadata is now available via our GeoData Gateway (GDG) at <http://geogateway.epa.gov>

Bringing More Data to the Public this Quarter:

- We more than doubled the number of datasets/tools/geodata on Data.gov (From nearly 600 to 1700)
- Toxic Release Inventory (TRI) datasets are widely used by many stakeholders, and now all current and historical TRI datasets are available; this quarter we:
 - Released initial 2009 TRI data quickly
 - Published remaining historical TRI datasets (1987 to 2004) to complete easy access to data from all TRI data years

OpenGov Performance and Measures

Objectives:

- Seek to measure outcomes, not just outputs
- Leverage current performance measures that support EPA's mission and OpenGov principles

Overall Approach:

- EPA is taking an iterative approach in developing performance, measures and metrics to track the effectiveness of actions taken to support the Agency's strategic goals through use of OpenGov principles
- First and foremost, we have met (or have plans in place to meet) the requirements in the [Open Government Directive](#)
- We established (or are establishing) quantitative metrics for each of our Flagship efforts
- We are in the process of identifying or developing qualitative measures with the Flagship teams and anticipate including them in our 2011/Q2 report

Employee Engagement

Objectives:

- Recognize that Agency employees have expertise and innovative ideas to contribute
- Create opportunities to actively solicit and promote employee input/suggestions

Employee Engagement Activities

- We are in the process of creating an Agency-wide resource for Open Government education, engagement and outreach including:
 - Open Government background (with links to Federal and EPA resources)
 - A repository of best practices, benefits and lessons learned
- As an initial step, we created a Wiki to capture various Community Engagement Flagship efforts leveraging EPA's existing Wiki environment
- The Wiki is being organized by categories of activities that promote broad applicability (e.g., pre regulatory engagement, use of Web 2.0 tools)
- Once sufficiently populated we will create an external view of Wiki content for transferability

Public Participation

Objectives:

- Solicit public input on the Agency's Open Government program, products, and direction
- Evaluate suggestions for implementation and provide the public a status and/or response for actionable items
- Create a process that involves the public at earlier stages of the Agency's activities

Approach:

To address and promote interactions with the public and respond to public suggestions, EPA is taking a maturity model approach and intends to take the steps identified below:

- Begin by collecting comments and summarizing/grouping similar ideas and suggestions
- Progress toward responding to comments and providing a status of actions
- Move to thoughtful, interactive dialog on specific topics and issues
- Identify trends in incoming suggestions/comments and evaluate them for adoption or action

Current Status/Update:

- IdeaScale
 - Based on public request, we kept the IdeaScale site active after publishing EPA's Open Government Plan
 - We are providing responses to actionable suggestions as part of our Quarterly progress reporting
- EPA began modifying the IdeaScale site on September 1, 2010 to prepare a solicitation of suggestions on more targeted program areas and OpenGov products
