



## **Top 30 Local Government**

As of April 25, 2022, the combined annual green power use of EPA's Top 30 Local Governments amounts to nearly 4.5 billion kilowatt-hours of green power, which is equivalent to the annual electricity use of nearly 417,000 average American homes.
