



Long-term Contracts

As of January 23, 2023, the combined annual green power use represented by the 518 Long-term contracts of EPA Green Power Partners amounts to more than 44 billion kilowatt-hours of green power, which is equivalent to the annual electricity use of nearly 4.2 million average American homes.
