



## **Top 30 On-site Generation**

As of April 24, 2023, the combined annual green power use from EPA Green Power Partners using onsite sources amounts to nearly 2 billion kilowatt-hours of green power, which is equivalent to the annual electricity use of nearly 185,000 average American homes.
