



Long-term Contracts

As of January 23, 2024, the combined annual green power use represented by the 676 Long-term contracts of EPA Green Power Partners amounts to more than 51.1 billion kilowatt-hours of green power, which is equivalent to the annual electricity use of more than 4.7 million average American homes.
