Welcome and introductions – Moderator – Gedi Cibas-Environmental Protection Agency for the State of New Mexico at the Santa Fe Office.

Gedi Cibas-Border 2012 will allow local input, permitting community level activities to provide input of their priorities.

Gedi Cibas-This plan envisions formation of workgroups.

The regional workgroups are going to be the foundation of the program – they are going to be in charge of coordination of the activities at a regional level.

The one relevant to us is the Texas-New Mexico- Chihuahua workgroup.

First, it will made-up of two co-chairs from each country at a state and federal level. Mexico and the US have agreed on having a similar number of co-chairs.

Texas and New Mexico would have to rotate co-chairs.

Some other groups will have the same issue because some will have even three states from the same country involved.

What is important is the incorporation of individuals that represent broad groups.

We have prototype and concepts of who would be able to participate.

People who know about different sectors of the environment.

Workgroups have to work in a transparent fashion.

Border 2012 rose from the Ten States. All projects are involved at a regional level and involve diverse environmental issues.

Steps involved:

Each four regional workgroups will convene in a session after 2012 has been signed; we will meet in early 2003.

Who needs to be involved....? Some of this will depend on you. Your participation is critical.

BECC and NAD Bank we hope, will participate, various NGOs community based organizations, universities on both sides of the frontier, private sector.

Regional workgroups will establish task forces to address issues and concerns.

Reporting of progress of program is very important, the first one at the end of 2003 and every two years from then on.

For the last two years, we have been conducting round tables; we were attempting to capture the concern of people, and to give us an idea of what these concerns are. These concerns will help us form an idea of specific issues.

Goals and objectives we are starting with goals and objectives. Are the regional groups going to determine if their goals and objectives going to be tied to the work groups?

These goals and objectives are preliminary, it has been done in a draft manner these are only for the time being, they are also based on science.

Border 2012 is based on Border XXI regional focus.

Environmental issues were identified, but how can we quantify? They are not pre-judged, the document you are holding is a draft; nothing that we have here is definite.

Mike Noonchester NMSU Border Technology ....Looking at immediate policy development ...Santa Teresa is designated as a HAZMAT Port .....there is a lot of controversy surrounding the role of this Port of Entry ...GSA has hired a consultant to reconstruct all Ports along the border ....Thus I would argue that it is critical that local governments address the redesign of HAZMAT ports of entry

NAFTA identifies the need for a major HAZMAT Port in this region ....this needs to be translated into a decision of what should take place locally ....there does not seem to be much cross agency coordination regarding port issues

Q

Follow up question ...the GSA consultant does not have a good working knowledge or even a "good feel" regarding optimal HAZMAT port design ...Does EPA have standards for HAZMAT design? If so how will these concerns be incorporated into Border 2012 goals?

EPA Region 6 " your concerns connect with Homeland Security issues...there are EPA standards and there are on-going efforts to deal with HAZMAT challenges and these efforts include coordination with other agencies such as TCEQ
