Sub-Group Updates – 45 min

East Branch Little Calumet & Salt Creek

Charlie is doing a study, and has sampled for it from 48 sites. The study will provide info that lays the groundwork for an EA. It will assess the ecological role of coarse woody debris in the river. Gene Fleming has restoration projects going on in the area that coincide with the East Branch of the Little Calumet or Trail Creek. Lynda mentioned CSOs and handicapped access. Jen update on WMP, GLISTEN students, 11 weekly sampling. Dan has been leading an outreach effort teaching urban children basics of paddling which is part of American Rivers grant. Angela Larsen has excel sheet of current projects and working map of areas of potential.

Trail Creek

Angela has potential opportunity to partner with Trail Creek. Natalie will put them in touch. Dan announced a clean-up occurring on July 13th with multiple partners (Shirley Heinze, NIPSCO, Save the Dunes, NWI Steelheaders, MC Chamber of Commerce, MC Parks. Tom Dilley mentioned there are current members w/grants in the area working on a grant regarding the emerald ash borer. Dan was able to acquire moneDan was able to acquire money from HUD for ADA access ramp for boat launch, Michigan City helped with cost. This project was fueled by UW.

Grand Calumet Area of Concern

CARE committee needs more representation from municipalities. Jennifer Gadzala reported the Vision Document was created with much public input. Diane or Kay will provide document for Natalie.

Side Topic: Paul wanted to know if writing Urban Waters into a grant would give grant more points—Natalie will investigate. Charlie mentioned the difficulties of covering overhead for UW small grants—can EPA redesign? Diane suggested the topic of grants is placed on the agenda for next month's meeting. Natalie will look for funding opportunities and pass along as well as who can provide match.
