I am writing to you with a vote of support for the Current Title V operating permit to remain in place. The Deseret Power Plant is one of the cleanest coal fired power plants in the country. If changes are made to the current plant structure this would greatly increase our residential and agricultural power bills, and could in turn render me unemployed if coal were discontinued. Any increase in the cost of power would be a huge detriment to the agriculture community in general as nearly all of our Jensen area farms and ranches use electric powered pumps to water the fields.

There is an inversion over our valley during the cold winter months which my grandfather says has been here as long as he can remember. He is 86 years old. I don't believe that the Bonanza Power plant poses a risk to the air quality in the Uintah Basin. I urge you to carefully consider all dynamics when making your decision. We live, work, and play here and love this area.



EPA proposes to Issue a Clean Air Act (CAA), 40 Code of Federal Register, Part 71, Title V Operating Permit for the following coal-fired electric utility on the Uintah and Ouray Indian Reservation.

> Deseret Power Electric Cooperative Bonanza Power Plant 12500 East 25500 South Vernai, Utah 84078

EPA issues CAA Title V operating permits in Indian country where EPA has not approved a tribe to Implement the TIBE V operating permit program. The Ute Indian Tribe on the Uintah and Ouray Indian Reservation does not have an approved Title V operating permit program.

Most air pollutant emissions come from the utility's main boiler. The draft operating permit includes requirements for air pollutant emissions control.
