## U.S. EPA Urban Waters Small Grants

#### Due: December 16, 2013

Funding of \$40,000 to \$60,000 is available for projects that advance the restoration of urban waters by improving water quality through activities that also support community revitalization and other local priorities. The funding is part of USEPA's Urban Waters program, and is one way that EPA is supporting the work and goals of the multiagency Urban Waters Federal Partnership.

NOAA Marine Debris Prevention through Education & Outreach

## Due: December 20, 2013

Projects awarded through this grant competition are expected to educate the public about marine debris through dedicated prevention activities. **Great Lakes projects are eligible.** This effort focuses on preventing marine debris from entering the environment through education and outreach rather than on removing debris that is already there.

Local Sustainability Matching Fund

#### Due: January 8, 2014

The Local Sustainability Matching Fund aims to advance important community-based sustainability initiatives and catalyze partnerships between local government sustainability directors and local, place-based foundations. The Fund will provide partnership investments between \$25,000 and \$75,000 for one year projects that advance discrete sustainability initiatives and demonstrate broad-based community support and engagement. A 1:1 match by one or more local foundations is required.
