

## **South Platte River Urban Waters Partnership**

## Meeting Notes | May 6, 2014 | 1:30 - 4:00 PM | The Daniels Fund

**Summary:** After workgroup updates and a sneak peak of the CO water movie, participants spent the majority of the meeting in small groups discussing the work of partner groups, their relevance to the UWP vision and vice versa, and how to encourage investment in the UWP. The Leadership Team will be compiling and analyzing the small group discussions to share back with the partnership.

Action Items: Participants identified a number of short-term action items, including:

- (Leadership Team) Revise the vision statement to clarify boundaries of the "South Platte River Watershed". A map is valuable, but can't always be used.
- (All) Contact Jim Havey to share places, photos, stories, water quality info, wildlife and recreation info, etc. that could be included in his film.
- (Jim Havey) Share video clip with those interested in distributing it among their networks or posting to the web.

Work Group Updates: Work group leads provided updates on current work and needs, including:

- Geomapping: Have made some tweaks to the platform, which will be rolled out soon to the other UWP locations. Need partner commitments to add project information and keep it up to date. - 2. Water Quality: Moving forward with partner survey results, defining project boundary, shared maps.
- 3. Education and Urban Engagement: Held a clean-up event at Bluff Lake and have another planned in June. World water monitoring day planning is ongoing.
- 4. Economic Benefits: Shared info on existing research ideas and study templates from USFS Rocky Mountain Research Station and CSU Extension.
- 5. Water Center: Looking for a workgroup leader. Focusing on engaging the right people and on outreach.
- 6. Leadership Team: Authored the UWP "profile" document, which is still open to evolution and intended to focus our efforts. Developed criteria to evaluate and respond to requests for letters of support, based on the vision/profile document.

**The Great Divide:** Jim Havey, from Havey Productions, shared information about development of the film "The Great Divide", a historic look at water in Colorado. He requested input from UWP members. The film will debut in spring 2015. See handout for additional details.

## Facilitated Table Discussion – Locally Driven Regional Collaboration

Partners discussed current projects and the benefits of participation in the UWP. Many organizations appreciate the networking, the opportunity to build relationships and share data. The group made suggestions as to how to pursue funding for the ongoing work of the partnership without duplicating fees already paid to other watershed groups. Some Partners are interested in supporting the UWP through available resources (staff time or financial,



if available), particularly if the support could be tied to projects. The suggestion was made to send out letters asking for a specific amount for a specific purpose. There was also support for approaching a major funder.
