Final Notice: Findings of Failure to Submit a Complete Section 110(a) Infrastructure State Implementation Plan for the 2006 Fine Particulate Matter (PM_{2.5}) NAAQS

FACT SHEET

ACTION

- On August 31, 2011, the U.S. Environmental Protection Agency (EPA) officially notified certain states, the District of Columbia, and the Commonwealth of Puerto Rico that they have failed to submit complete State Implementation Plans (SIPs) that include the infrastructure elements necessary to ensure implementation of the 2006 24-hour PM_{2.5} NAAQS.
- The infrastructure elements for which findings are being made are listed in the table below. These elements are the building blocks of state air quality management programs.
- Today's action is a finding for each of these areas for having failed to make a complete submission for all or some of the specific requirements.
- In September 2006, the EPA revised the 24-hour PM_{2.5} primary and secondary NAAQS from 65 micrograms per cubic meter (μg/m³) to 35μg/m³. States were required to submit infrastructure SIPs by September 21, 2009.
- These findings establish a 24-month deadline for the EPA to either approve a SIP or finalize a FIP that addresses the outstanding SIP elements for each of these areas.
- The table below shows the District of Columbia, the Commonwealth of Puerto Rico, and the 6 states that failed to submit complete infrastructure SIPs, and the specific infrastructure elements associated with each area.

BACKGROUND

- On 1/12/11, Sierra Club and WildEarth Guardians (plaintiffs) filed a complaint pertaining to infrastructure SIPs for the 2006 24-hour PM_{2.5} NAAQS against states for which the EPA: (1) has failed to take final action on within 1 year after the SIP submission was deemed complete (claim one); and (2) has a mandatory duty to make findings of failure to submit with respect to one or more infrastructure SIP elements for alleged states that had not made submissions (claim two).
- On 7/6/11, the plaintiffs filed an amended complaint. In the amended complaint the plaintiffs: (1) name 20 states that the EPA has failed to take final action on within 1 year after the SIP submission was deemed complete (claim one); and (2) name 14 states and areas that had not made infrastructure submissions to address various elements for sections 110(a)(2)(A) thru (M) for the 2006 24-hour PM_{2.5} NAAQS (claim two).
- Because 6 states submitted complete infrastructure SIPs before August 31, 2011, the total number of areas receiving a finding of failure will be reduced to 8 from the 14 named areas in the complaint. The states that submitted complete infrastructure SIPs are Illinois, Michigan, Idaho, Nebraska, Wyoming, and Oregon.
- In order to resolve claim 2 in the amended complaint, for states and areas that have failed to submit infrastructure SIPs, the EPA is taking this action.
