## NOTICE OF INTENT TO ISSUE A DRAFT CLEAN AIR ACT PART 71 PERMIT TO OPERATE FOR CLOQUET COMPRESSOR STATION NO. 5

The U. S. Environmental Protection Agency requests public comment on the draft Air Pollution Control Title V Permit to Operate for Cloquet Compressor Station No. 5 (Permit No. V-FDL-2713700066-2016-03) located at 3741 Brandon Road, Cloquet, Minnesota. The public comment period for the draft permit ends **August 1, 2016**.

This action would permit Great Lakes Gas Transmission Limited Partnership to operate air emission units and conduct other air pollutant emitting activities in accordance with the permit conditions listed in the permit. Air emission units at the facility include three stationary natural gas-fired turbines and one stationary natural gas-fired electrical generator. The permit text has been reformatted and, as a result, the permit condition numbering system has changed from the previous permit. In addition to formatting changes, permit requirements have been modified to include: 1) applicable requirements for the electrical generator as a non-emergency engine under 40 C.F.R. Part 63, Subpart ZZZZ; and 2) semi-annual reporting and deviation reporting requirements have been modified to include notifications to the Fond du Lac Band of Lake Superior Chippewa.

All written comments should include the reason for interest in the draft permit, requested actions for EPA to take, and the justification for such actions. All comments should include sufficient specificity and regulatory references to allow EPA to investigate the merits of the position.

Members of the public may also request a public hearing. A request for a public hearing must be made in writing and must state the nature of the issues proposed to be raised at the hearing. Written requests for a public hearing should be sent to the EPA Region 5 address listed above.

All relevant comments received prior to the end of the public comment period will be considered in arriving at a final decision on the permit. All comments will be included in the public docket without change and may be made available to the public, including any personal information provided, unless the comment includes Confidential Business Information (CBI) or other information whose disclosure is restricted by statute. Information that you consider CBI or otherwise protected should be clearly identified as such and should not be submitted through e-mail. If you send e-mail directly to EPA, your e-mail address will be captured automatically and included as part of the public comment. Please note that an e-mail or postal address must be provided with your comments if you wish to receive direct notification of EPA's final decision regarding the permit and its responses to comments submitted during the public comment period. The final permit is a public record that can be obtained upon request. A statement of reasons for changes made to the draft permit and responses to comments received will be sent to all persons who commented on the draft permit. If you believe any condition of the draft permit is inappropriate or that our initial decision to deny an application, terminate a permit, or prepare a draft permit is inappropriate, you must raise all reasonably ascertainable issues and submit all reasonably ascertainable arguments supporting your position by the end of the comment period.
