Re: U.S. EPA's Supplemental Notice of Approval With Modifications of Enbridge Energy, Limited Partnership's Pipeline Repair Workplan, which was submitted by Enbridge in response to the Removal Administrative Order issued by U.S. EPA on July 27, 2010, pursuant to §311(c) of the Clean Water Act in Docket No. CWA 1321-5-10-001

Dear Mr. Fridel:

Yesterday, I sent you the United States Environmental Protection Agency (U.S. EPA) approval with modifications to the Enbridge Energy, Limited Partnership's Pipeline Repair Workplan. Today, I am supplementing that approval with two additional modifications.

As required by my August 3, 2010, letter, U.S. EPA approves, with modifications, this plan and asks for a clean hard copy to be submitted to the U.S. EPA Incident Commander (IC) by no later than 5pm on August 5th, 2010. Until the revised hardcopy is available to replace the current version, the Workplan as submitted may be used as long as U.S. EPA's corrections are attached to the Workplan and are adhered to.


Enbridge must make the following supplemental modifications for the IC's approval of your Workplan:

1. Enbridge shall notify the federal On-Scene Coordinator and Incident Commander at least 8 hours prior to moving the ruptured pipeline or altering it in anyway, including but not limited to cutting the pipe. Enbridge must await the federal On-Scene Coordinator and Incident Commander's approval before undertaking such actions.
2. Enbridge shall notify the federal On-Scene Coordinator and Incident Commander at least 8 hours prior to any discharge to surface waters of any dewatered liquids from the area surrounding the pipeline. Enbridge must await the federal On-Scene Coordinator and Incident Commander's approval before undertaking such actions.

Along with the specific comments set forth in the August 3, 2010 approval letter, Enbridge shall incorporate the modifications identified above into the revised plan,

pursuant to Paragraph 20 of the July 27, 2010, EPA Order. To the extent that Enbridge has questions or concerns regarding the enclosed comments, Enbridge must immediately inform the IC or designated agency representative.
