RE: Update on Recommended Area Designations for the 2010 Primary NAAQS for SO₂ (75 FR 35520, June 22, 2010) and Modeling Report for North Valmy Generating Station, Nevada, 2015 SO₂ Data Requirements Rule (40 CFR Part 51, Subpart BB)

Dear Ms. Strauss:

On behalf of Governor Sandoval, as his appointed designee, pursuant to section 107(d)(1) of the 1990 Clean Air Act Amendments and the SO₂ Data Requirements Rule (DRR, August 21, 2015), I am submitting this letter with the updated recommendations for the **hydrographic area HA64** of the State of Nevada to be designated **unclassifiable**. Section 107(d)(1)(A)(iii) of the Clean Air Act states that an unclassifiable designation is appropriate for "any area that cannot be classified on the basis of available information as meeting or not meeting the national primary or secondary ambient air quality standard for the pollutant." The NDEP affirms that modeling is not an appropriate substitute for monitoring for attainment designations (Comments to DDR Docket EPA-HQ-OAR-2013-0711, July 14, 2014), and monitoring data are not available in HA64 to make an attainment or nonattainment designation. However, per the requirements of the SO₂ Data Requirements Rule (DRR, August 21, 2015), a modeling analysis was conducted for the North Valmy Generating Station (Valmy) located in HA64. The modeling results show that concentrations of SO₂ surrounding Valmy meet the NAAQS standard for SO₂ (see attached Air Dispersion Modeling Report).
