Administrative Settlement Agreement

Docket No. AED/MSEB #8298

- This is an Administrative Settlement Agreement (Agreement) between the United States
  Environmental Protection Agency (EPA) and KION North America Corporation (KION)

  (collectively, Parties). The purpose of this Agreement is to resolve alleged violations of the Clean Air Act (CAA) and its regulations by KION.
- KION is a corporation organized under the laws of the State of Delaware with a
  registered principal place of business at 2450 W. 5th North St., Summerville, SC 29483.
   KION imports equipment of various kinds, including diesel powered fork lifts.
- The delegated official of the EPA and signatory to this Agreement is the Director of the Air Enforcement Division of the Office of Civil Enforcement of the Office of Enforcement and Compliance Assurance. The EPA enters this Agreement pursuant to sections 205(c) and 213(d) of the CAA, 42 U.S.C. §§ 7524(c) and 7547(d), and 40 C.F.R. § 1068.125.

### Governing Law

- This Agreement concerns Part A of Title II of the CAA, CAA §§ 202-219, 42 U.S.C. §§ 7521-7554, and related regulations. These laws aim to reduce emissions from mobile sources of air pollution. The Alleged Violations of Law, stated below, regard freshly manufactured engines for which 40 C.F.R. Part 1033 sets exhaust emission standards and 40 C.F.R. Part 1068 sets compliance provisions. This section of the Agreement summarizes the law that governs these allegations.
- Model year 2014-2016 non-road compression ignition (diesel) engines must satisfy air pollution exhaust emission standards in 40 C.F.R. Part 1039. Subpart B. These exhaust emission standards impose limits on emissions of hydrocarbons, oxides of nitrogen. carbon monoxide, and particulate matter. 40 C.F.R. §§ 1039.101 and 1039.102.
- The EPA's certification program is designed to ensure that every engine introduced into United States commerce conforms in all material respects to a design that has been approved by the EPA. The EPA approves diesel engines by issuing certificates of conformity (COCs).
- To obtain a COC. a manufacturer must submit a COC application to the EPA for each
  engine family and for each model year that it intends to introduce into United States
  commerce. 40 C.F.R. Part 1039, Subpart C (outlining emission certification
  requirements).
- The COC application must describe the engines' specifications and demonstrate with test data that its exhaust emissions satisfy applicable emission standards. 40 C.F.R § 1039.205.



- Once issued, a COC covers only those engines produced during the period of time specified in the application for that COC, and covers no engine produced before the date that the manufacturer submitted the application for that COC nor any engine produced after December 31 of the calendar year for which the model year is named. 40 C.F.R. §§ 1039.201(a), 1068.103(a), (c), (d).
- 10. A manufacturer may not sell, offer for sale, introduce into commerce, deliver for introduction into commerce, or import (or cause any of the foregoing with respect to) a new diesel engine unless it is covered by a COC or is otherwise exempt from certification requirements. 40 C.F.R. § 1068.101(a)(1).
- 11. A person who violates 40 C.F.R. § 1068.101(a)(1) after January 12, 2009, and before November 2, 2015, is subject to a civil penalty of not more than \$37,500 for each violation and any person who is assessed a penalty for violating 40 C.F.R. § 1068.101(a)(1) after July 30, 2016, for violations occurring after November 1, 2015, is subject to a civil penalty of not more than \$44,539 for each violation, 40 C.F.R. §§ 19.4 and 1068.101(a)(1).

#### Factual Background

KION voluntarily disclosed that in February 2016 it had imported into the United States
fork lifts containing diesel engines which were represented by Volkswagen AG (VW)
as certified but were not, in fact, covered by a model year 2016 COC because they were
manufactured before issuance of a model year 2016 certificate. No notification of early
manufacture was submitted by VW pursuant to 40 C.F.R. § 1068.103(c)(3).

- KION also disclosed that VW had supplied 2016 model year emission labels for the 56 engines.
- 14. KION also disclosed that 35 of the 56 engines were manufactured during calendar year 2015, and 21 were manufactured during calendar year 2016 and were voluntarily exported back to Germany by KION.
- 15. KION voluntarily disclosed that it sold in the United States 133 forklifts containing diesel engines that were manufactured before March 27, 2015, were labeled as model year 2015 engines and represented by VW as covered by a model year 2015 COC, but were not covered by a model year 2015 COC because they were manufactured before issuance of a model year 2015 certificate. No notification of early manufacture was submitted by pursuant to 40 C.F.R. § 1068.103(c)(3).
- 16. KION voluntarily disclosed that it sold in the United States 25 forklifts containing diesel engines that were manufactured before February 2, 2014, were labeled as model year 2014 engines and represented by VW as covered by a model year 2014 COC, but were not covered by a model year 2014 COC because they were manufactured before issuance of a model year 2014 certificate. No notification of early manufacture was submitted by VW pursuant to 40 C.F.R. § 1068.103(c)(3).
- In total KION imported 214 forklifts containing uncertified engines (the Subject Engines). The Subject Engines are further described in Attachment I.
- 18. On or about August 31, 2016, the EPA's Office of Transportation and Air Quality (OTAQ) issued a model year 2016 COC to VW to cover diesel engines used by KION in fork lifts.

19. KION has applied supplemental labels to 21 engines that were manufactured in calendar year 2016 and may import those engines. Each label is adjacent to the existing emission control information labels that are required by 40 C.F.R. § 1039.135, will be durable throughout the Subject Engines' useful life, and cannot be removed without being destroyed or defaced. Each label states: "This engine is not EPA certified, but is legal for sale pursuant to the terms of a settlement agreement with the US EPA, Docket AED/MSEB #8298. KION North America Corporation has committed to perform any and all requirements under the Clean Air Act and applicable regulations as though it was a certified model year 2016 engine."

# Alleged Violations of Law

20. KION violated 40 C.F.R. § 1068.101(a)(1) when it sold, offered for sale, introduced into commerce, delivered for introduction into commerce or imported (or caused the foregoing with respect to) the Subject Engines. The Subject Engines are not covered by a COC because VW manufactured the Subject Engines before the date that VW submitted the applications for the COCs which could have covered the Subject Engines.



#### Terms of Agreement

#### 21. KION:

- (a) agrees that the EPA has jurisdiction over this matter under section 205(c) of the CAA, 42 U.S.C. § 7524(c):
- (b) admits to the Factual Background stated above;
- (c) neither admits nor denies the Alleged Violations of Law stated above;
- (d) agrees to pay the civil penalty stated below:
- (e) agrees to any conditions specified in this Agreement:
- (f) waives any right to any hearing, trial, adjudication, or proceeding (including review under sections 205(c) and 307(b)(1) of the CAA, 42 U.S.C. §§ 7534(c) and 7607(b)(1)) on any terms of this Agreement and on any issue of law or fact related to the Alleged Violations of Law and Factual Background stated above:
- (g) waives any rights it may possess at law or in equity to challenge the authority of the EPA to bring a civil action governed by federal law in a United States District Court to enforce this Agreement and to seek additional remedies for such breach:
- (h) agrees that KION may not delegate KION's duties under this Agreement to any other person without the written consent of the EPA, which may be granted, conditionally granted, or withheld at the EPA's unfettered discretion;
- acknowledges that this Agreement constitutes an enforcement action for purposes of considering KION's compliance history in any subsequent enforcement action:



- (j) acknowledges that this Agreement will be available to the public and agrees that it does not contain any confidential business information or personally identifiable information:
- (k) acknowledges that its tax identification number may be used for collecting or reporting any delinquent monetary obligation arising from this Agreement (see 31 U.S.C. § 7701):
- certifies that the information it has supplied concerning this matter was at the time of submission true, accurate, and complete; and
- (m) acknowledges that there are significant penalties for knowingly submitting false or misleading information, including the possibility of fines and imprisonment (see, e.g., 18 U.S.C. § 1001).
- 22. For purposes of this proceeding, the Parties, desiring to settle this matter, each agree that:
  - this Agreement is in the public interest and is an appropriate way to resolve this matter;
  - (b) this Agreement constitutes the entire agreement and understanding of the parties and supersedes any prior agreements or understandings, whether written or oral, among the parties with respect to the subject matter hereof;
  - this Agreement may be signed in any number of counterparts, each of which will be deemed an original and, when taken together, constitute one agreement; the counterparts are binding on each of the parties individually as fully and completely as if the parties had signed one single instrument, so that the rights and liabilities of the parties will be unaffected by the failure of any of the undersigned to execute any or all of the counterparts; any signature page and any

- copy of a signed signature page may be detached from any counterpart and attached to any other counterpart of this Agreement;
- (d) its undersigned representative is fully authorized by the Party whom he or she represents to bind that Party to this Agreement and to execute it on behalf of that Party:
- (e) each Party's obligations under this Agreement constitute sufficient consideration for the other Party's obligations under this Agreement; additionally, the Parties agree that the EPA's covenant not to sue KION (stated below) during the time period between the date that the EPA signs this Agreement and termination of the EPA's covenant (if and when this occurs) constitutes sufficient consideration for the satisfactory completion of each and every one of KION's obligations under this Agreement; and
- (f) each Party will bear its own costs and attorney fees in the matter resolved by this Agreement.
- 23. KION agrees to pay to the United States a civil penalty of \$200.000 (the Civil Penalty).
- 24. KION agrees to pay the Civil Penalty to the United States within 30 calendar days following the date that the EPA signs this Agreement. The EPA agrees to provide to KION at the email address provided on KION's signature page, below, a copy of the executed Agreement within 5 calendar days of that date.
- 25. KION agrees to pay the Civil Penalty in the manner specified below:
  - (a) Pay the Civil Penalty using any method provided on the following website: http://www2.epa.gov/financial/additional-instructions-making-payments-epa:
  - (b) Identify each and every payment with "AED/MSEB #8298": and



- (c) Within 24 hours of payment, email proof of payment to David Alexander at alexander, david a epa.gov ("proof of payment" means, as applicable, a copy of the check, confirmation of credit card or debit card payment, confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate that payment has been made according to EPA requirements, in the amount due, and identified with "AED/MSEB #8298").
- 26. KION commits to perform any and all responsibilities it would otherwise have had if the Subject Engines had been covered by an FPA-issued COC. This includes all post-certification compliance obligations required of the certifying manufacturer that are specified in 40 C.F.R. Parts 1039 and 1068, including requirements concerning in-use testing, defect reporting, warranty, remanufacturing, and recordkeeping and reporting.
- 27. KION agrees to pay stipulated penalties of \$3,000 per day to the EPA if it fails to timely pay the Civil Penalty, or provide proof thereof. Such payment shall be in accordance in the manner specified by Paragraphs 24 and shall be remitted not more than 30 days after receipt of written demand by the EPA for such penalties.

## Effect of Agreement

28. By its signature below, the EPA covenants not to sue KION for civil penalties for the Alleged Violations of Law stated above, but such covenant automatically terminates: 90 days after the date that the EPA signs this Agreement if on that date KION has failed to pay the Civil Penalty required by Paragraphs 23–25 and pay any and all stipulated penalties demanded under Paragraph 27. If and when such covenant terminates, the United States at its election may seek to compel performance of the terms of this



Agreement and seek other relief in a civil administrative or judicial action under the CAA, as a matter of contract, or both.

- If KION fails to timely pay any portion of the Civil Penalty, the EPA may:
  - request that the Attorney General bring a civil action in an appropriate district court to recover: the amount assessed; interest at rates established pursuant to 26 U.S.C. § 6621(a)(2); the United States' enforcement expenses; and a 10% quarterly nonpayment penalty (see 42 U.S.C. § 7524(c):
  - (b) refer the debt to a credit reporting agency or a collection agency (see 42 U.S.C. § 7524(c)(6), 40 C.F.R. §§ 13.13, 13.14, and 13.33);
  - (c) collect the debt by administrative offset (i.e., the withholding of money payable by the United States to, or held by the United States for, a person to satisfy the debt the person owes the United States), which includes, but is not limited to, referral to the Internal Revenue Service for offset against income tax refunds (see 40 C.F.R. Part 13, Subparts C and II); and
  - (d) suspend or revoke KION's licenses or other privileges, or suspend or disqualify KION from doing business with the EPA or engaging in programs the EPA sponsors or funds (see 40 C.F.R. § 13.17).
- Penalties paid pursuant to this Agreement are not deductible for federal tax purposes.
   U.S.C. § 162(f).
- 31. This Agreement applies to and is binding upon the KION. Successors and assigns of KION are also bound if they are owned, in whole or in part, directly or indirectly, or otherwise controlled by KION or if they continue a substantive portion of KION's business that is regulated under the CAA. Nothing in the previous sentence adversely



- affects any right of the EPA under applicable law to assert successor or assignee liability against KION's successor or assignee.
- 32. Nothing in this Agreement shall relieve KION of the duty to comply with all applicable provisions of the CAA or other federal, state, or local laws or statutes, nor shall it restrict the EPA's authority to seek compliance with any applicable laws or regulations, nor shall it be construed to be a ruling on, or determination of, any issue related to any federal, state, or local certificate, license, or permit.
- 33. The EPA reserves the right to terminate its covenant provided by this Agreement if and to the extent the EPA finds, after signing this Agreement, that any information provided by KION was or is materially false or inaccurate. If and when such termination occurs, the EPA reserves the right to pursue, assess, and enforce legal and equitable remedies for the Alleged Violations of Law. The EPA shall give KION written notice of such termination, which will be effective upon mailing.
