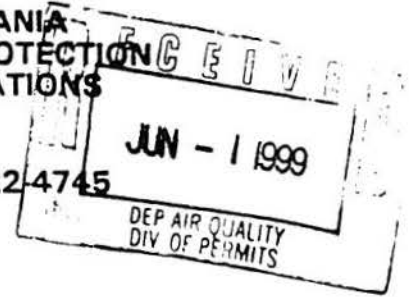

**RACT OPERATING PERMIT**

In accordance with provisions of the Air Pollution Control Act of January 8, 1960, P.L. 2119, as amended, and after due consideration of an application received under Chapter 127 of the Rules and Regulations of the department of Environmental Protection, the Department hereby issues this permit for the operation of the air contamination source(s) described below.

  - (c) operated and maintained in a manner consistent with good operating and management practices.
2. This permit is valid only for the specific equipment, location and owner named above.

Conditions for RACT Permit OP-04-000-043

3. This Reasonably Available Control Technology (RACT) operating permit approves RACT proposal submitted by United Coaters for the Ambridge Plant in Beaver County, PA.
4. RACT for the previously unregulated VOC emissions at this facility shall be the operation and maintenance of the Paint Mix Station and the Solvent cleaning operations in accordance with the manufacturers' specifications and operating instructions, and in accordance with good air pollution control practice.
5. The emission limits for these operations shall be 9 TPY of volatile organic compounds of which no more than 6 TPY shall be HAP's. United Coaters shall seek to use solvents which will further reduce these releases.
6. United Coaters shall record hours of operation of the coating line, natural gas consumption and VOC usage data in accordance with the requirements of 25 PA Code §129.52 (c) and §129.95.
7. The Department reserves the right to revise the emission limits and the reporting requirements based upon the values reported, changes in the coatings used and observations of the operating practices.
8. The expiration date shown on this RACT operating permit is for state purposes. For Federal enforcement purposes, the conditions of the operating permit which pertain to the implementation of the RACT regulations shall remain in effect as part of the State Implementation Plan (SIP) until replaced pursuant to 40 CFR 51.4 and approved by the U.S. Environmental Protection Agency (EPA).
