TSCA Section 5(a)(3) Determination: Chemical substance not likely to present an unreasonable risk (5(a)(3)(C))

Chemical Name:

Specific: Alcohols, C12-13-branched and linear, dimerized (CASRN: 2041102-78-5).

Assessed Conditions of Use (intended, known, or reasonably foreseen)¹:

Intended use(s) (specific): Additive in Metalworking Fluids; Additive in Minimum Quantity Lubricant for metalworking; Chemical Intermediate for Alcohol Derivatives. Known and reasonably foreseen use(s): Lubricant and lubricant additive; Defoamer; Chemical intermediate.

Summary: The chemical substance is not likely to present an unreasonable risk based on low human health concern and low environmental hazard. Although EPA estimated that the new chemical substance would be persistent, this did not indicate a likelihood that the chemical substance would present an unreasonable risk, given that the chemical substance has low potential for bioaccumulation, low human health concern, and low environmental hazard.

Fate: Environmental fate is the determination of which environmental compartment(s) a chemical moves to, the expected residence time in the environmental compartment(s) and removal and degradation processes. Environmental fate is an important factor in determining exposure and thus in determining whether a chemical may present an unreasonable risk. EPA estimated a number of physical/chemical and fate properties of this new chemical substance using submitted data for the new chemical substance and EPI (Estimation Programs Interface) Suite, a suite of physical/chemical property and environmental fate estimation programs (https://www.epa.gov/tsca-screening-tools/epi-suitetm-estimation-program-interface). Overall, these estimates were indicative of low potential for this chemical substance to volatilize into the air or migrate into ground water and that the substance would be effectively removed should it be released into wastewater.

Persistence²: Persistence is relevant to whether a new chemical substance is likely to present an unreasonable risk because chemicals that are not degraded in the environment at rates that prevent substantial buildup in the environment, and thus increase potential for exposure, may present a risk if the substance presents a hazard to human health or the environment.

¹ Intended uses are those identified in the section 5(a) notification. EPA identifies "known" and "reasonably foreseen" uses of the new chemical substance based on evidence of current use of the new chemical substance outside the United States and evidence of the current uses of chemical substances that are structurally analogous to the new chemical substance. EPA identifies uses based on searches of internal CBI EPA PMN databases (containing use information on analog chemicals), other U.S. government public sources, the National Library of Medicine's Hazardous Substances Data Bank (HSDB), the Chemical Abstract Service STN Platform, REACH Dossiers, technical encyclopedias (e.g., Kirk-Othmer and Ullmann), and Internet searches.

² Persistence: A chemical substance is considered to have limited persistence if it has a half-life in water, soil or sediment of less than 2 months or there are equivalent or analogous data. A chemical substance is considered to be persistent if it has a half-life in water, soil or sediments of greater than 2 months but less than or equal to 6 months or if there are equivalent or analogous data. A chemical substance is considered to be very persistent if it has a half-life in water, soil or sediments or there are equivalent or analogous data. A chemical substance is considered to be very persistent if it has a half-life in water, soil or sediments of greater than 6 months or there are equivalent or analogous data. (64 FR 60194; November 4, 1999)

EPA estimated biodegradation half-lives of this new chemical substance using submitted biodegradation data for the new chemical substance, data on analogous chemical substances, and EPI (Estimation Programs Interface) Suite (www.epa.gov/tsca-screening-tools/epi-suitetm-estimation-program-interface). These estimates indicate that the chemical substance is persistent.

Bioaccumulation³: Bioaccumulation is relevant to whether a new chemical substance is likely to present an unreasonable risk because substances that bioaccumulate in aquatic and/or terrestrial species pose the potential for elevated exposures to humans and other organisms via food chains. EPA estimated the potential for the new chemical substance to bioaccumulate using data on analogous chemical substances. These estimates indicate that this new chemical substance has low bioaccumulation potential.

Human Health Hazard⁴: Human health hazard is relevant to whether a new chemical substance is likely to present an unreasonable risk because the significance of the risk is dependent upon both the hazard (or toxicity) of the chemical substance and the extent of exposure to the substance. EPA estimated the human health hazard of this chemical substance based submitted data on the PMN substance, estimated physical/chemical properties (which indicate that it will be poorly absorbed if inhaled, ingested or by dermal contact), and by comparing it to structurally analogous chemical substances for which there is information on human health hazard. There is low concern for human health for the chemical, as well as estimates of potential hazard based on analogous chemical substances/structure-activity relationships.

Environmental Hazard⁵: Environmental Hazard: Environmental hazard is relevant to whether a new chemical substance is likely to present unreasonable risks because the significance of the

³ Bioaccumulation. A chemical substance is considered to have a low potential for bioaccumulation if there are bioconcentration factors (BCF) or bioaccumulation factors (BAF) of less than 1,000 or there are equivalent or analogous data. A chemical substance is considered to be bioaccumulative if there are BCFs or BAFs of 1,000 or greater and less than or equal to 5,000 or there are equivalent or analogous data. A chemical substance is Considered to be very bioaccumulative if there are BCFs or BAFs of 5,000 or greater or there are equivalent or analogous data. (64 FR 60194; November 4 1999)

⁴ A chemical substance is considered to have low human health hazard if effects are observed in animal studies with a No Observed Adverse Effect Level (NOAEL) equal to or greater than 1,000 mg/kg/day or if there are equivalent data on analogous chemical substances; a chemical substance is considered to have moderate human health hazard if effects are observed in animal studies with a NOAEL less than 1,000 mg/kg/day or if there are equivalent data on analogous chemical substances; a chemical substance is considered to have high human health hazard if there is evidence of adverse effects in humans or conclusive evidence of severe effects in animal studies with a NOAEL of less than or equal to 10 mg/kg/day or if there are equivalent data on analogous chemical substances. In the absence of animal data on a chemical or analogous chemical substance, EPA may use other data or information such as from in vitro assays, chemical categories^{6,7}, structure-activity relationships, and/or structural alerts to support characterizing human health hazards.

⁵ A chemical substance is considered to have low ecotoxicity hazard if the Fish, Daphnid and Algae LC50 values are greater than 100 mg/L, or if the Fish and Daphnid chronic values (ChVs) are greater than 10.0 mg/L, or there are not effects at saturation (occurs when water solubility of a chemical substance is higher than an effect concentration), or the log Kow value exceeds QSAR cut-offs. A chemical substance is considered to have moderate ecotoxicity hazard if the lowest of the Fish, Daphnid or Algae LC50s is greater than 1 mg/L and less than 100 mg/L, or where the Fish or Daphnid ChVs are greater than 0.1 mg/L and less than 10.0 mg/L. A chemical substance is considered to have high ecotoxicity hazard, or if either the Fish, Daphnid or Algae LC50s are less than 1 mg/L, or any Fish or Daphnid ChVs is less than 0.1 mg/L (Sustainable Futures https://www.epa.gov/sustainable-futures-p2-framework-manual).

risk is dependent upon both the hazard (or toxicity) of the chemical substance and the extent of exposure to the substance. EPA estimated environmental hazard of this new chemical substance using the Ecological Structure Activity Relationships (ECOSAR) Predictive Model (https://www.epa.gov/tsca-screening-tools/ecological-structure-activity-relationships-ecosar-predictive-model) and data on analogous chemical substances. Based on these estimated hazard values from ECOSAR, EPA concludes that this chemical substance has low environmental hazard.⁶

Potential Exposures: The exposure to a new chemical substance is potentially relevant to whether a new chemical substance is likely to present unreasonable risks because the significance of the risk is dependent upon both the hazard (or toxicity) of the chemical substance and the extent of exposure to the substance. Due to low hazard, EPA believes that this chemical substance would be unlikely to present an unreasonable risk even if exposures were high.

Potentially Exposed or Susceptible Subpopulation(s): Workers are potentially exposed. Given the low hazard of this chemical substance, EPA finds that this chemical substance is not likely to present unreasonable risk to workers.
