Revised Puerto Rico's Modeling Results for the 2010 Primary SO₂ National Ambient Air Quality Standards (NAAQS) Recommendation for Non-Attainment Areas Designation

As required by Title 40 of the Code of Federal Regulations, Section 51.1203(d)(3), Air Agencies shall conduct and submit to the EPA Regional Office the Modeling Analysis for Emission Sources with SO₂ emission on or above 2,000 tons per year (tpy), for its associate area and nearby area. Air Agencies shall conduct and submit modeling analysis on or before January 13, 2017. On December 19, 2016, Environmental Quality Board (EQB) sent the Puerto Rico's Modeling Results for the 2010 Primary SO₂ NAAQS Recommendation for Non-Attainment Areas Designation.

According to EPA recommendations, EQB revised the 1-hour SO₂ Designation Modeling Analysis previously submitted to EPA on December 19, 2016. The revision includes the following geographical areas of the Puerto Rico: Guayama-Salinas, Guayanilla and San Juan. Table 1 summarizes the modeling results.

According to the modeling results, the SO_2 emissions for three (3) of the four (4) facilities included in the study, do not comply with the 1-hour SO_2 NAAQS of 196 µg/m³.

Based on the modeling results, EQB recommends to EPA the designation of Guayama-Salinas, and San Juan as Non-Attainment Areas for the 1-hour SO₂ NAAQS, and Unclassified/Attainment Area for the remaining geographical areas of Puerto Rico.
