Approaches E and F – Limit Reporting for Site-Specific Catalyst Recycling (E) and for Reuse of Inorganic Byproducts (F) (2:10 – 2:50 PM) [Contingent on development of proposals]

Jim Cooper, American Fuel and Petrochemical Manufacturers (AFPM) and others, will provide updated descriptions of these approaches. Approach E limits reporting for catalyst recycling, when as an inorganic byproduct that is recycled, reused, or reprocessed either at the site of byproduct manufacture or at a different site, is returned to the site of byproduct manufacture for further use or processing. Approach F limits reporting

for inorganic byproducts that are isolated from a process and later reintroduced into that same process. The Committee will discuss questions of clarification, share strengths and considerations/concerns, and whether to continue exploring these approaches.
