PERMIT CONDITIONS

LOCATION: Clinton Township, Lycoming County

- This operating permit incorporates Reasonably Available Control Technology (RACT)
 determinations as required by the provisions of the Clean Air Act Amendments and 25 Pa. Code
 Sections 129.91 through 129.95 for the following sources:
 - · coil coating line paint reservoir flushing operations
 - · floor wiping operations
 - the burners associated with 20 natural gas-fired curing ovens having a total heat input of 15.2 million BTU/hour
 - 28 natural gas-fired space heaters with a total heat input of 6.72 million BTU/hour
 - 2.4 million BTU/hour heat input natural gas-fired boiler
 - .96 million BTU/hour heat input natural gas-fired "Water Tower Fire Control" heater
 - 2.5 million BTU/hour heat input natural gas-fired catalytic oxidizer burner
 - solvent cleaning sink or unit
 - 31 horsepower natural gas-fired emergency generator.
- 4. The expiration date shown in this permit is for state purposes. For Federal enforcement purposes, the conditions of this operating permit which pertain to the implementation of the RACT regulations shall remain in effect as part of the State Implementation Plan (SIP) until replaced pursuant to 40 CFR 51 and approved by the U.S. Environmental Protection Agency (EPA).
- 5. The potential to emit volatile organic compounds from each of the following 4 air contamination source categories shall never exceed 3 pounds per hour, 15 pounds per day or 2.7 tons per year (as determined by the Department). Should any of these limitations ever be exceeded for any of the source categories listed below, a detailed RACT analysis which meets the criteria specified in Section 129.92 of Chapter 129 of Article III of the Rules and Regulations of the Department of Environmental Protection must be submitted to the Department for each individual air contamination source within the respective source category or categories.
 - coil coating line paint reservoir flushing and floor wiping operations identified in condition 3 herein
 - the curing oven burners, the 28 space heaters, the boiler, the "Water Tower Fire Control" heater and the catalytic oxidizer burner identified in condition 3 herein
 - solvent cleaning sink or unit identified in condition 3 herein
 - emergency generator identified in condition 3 herein.
- 6. Pursuant to Section 129.95 of Chapter 129 of Article III of the Rules and Regulations of the Department of Environmental Protection, the permittee shall maintain, and make available to the Department upon request, comprehensive accurate records of the following:

- the amount of fresh volatile organic compound containing solvent used per month for coil coating line paint reservoir flushing and the amount of spent volatile organic compound - containing solvent generated per month from reservoir flushing
- the amount of volatile organic compound containing solvent used per month for floor wiping
- the total combined natural gas usage per month for the curing oven burners, the 28 space heaters, the boiler, the "Water Tower Fire Control" heater and the catalytic oxidizer burner identified in condition 3 herein
- the amount of fresh solvent added per month to the solvent cleaning sink or unit identified in condition 3 herein and the amount of spent solvent removed from the sink or unit per month
- the number of hours per month the emergency generator identified in condition 3 herein is operated.
- 7. The operation of the aforementioned sources shall not at any time result in the emission of volatile organic compounds in excess of the limitations specified in any condition contained herein, or in the emission of this or any other type of air contaminant in excess of the limitations specified in, or established pursuant to, any applicable Rules and Regulations of the Department of Environmental Protection.
- 8. The permittee shall immediately notify the Department of any malfunction of the source(s) or associated air cleaning device(s) which results in, or may possibly be resulting in, the emission of air contaminants in excess of the limitations specified in, or established pursuant to, any applicable rule or regulation contained in Article III of the Rules and Regulations of the Department of Environmental Protection or in excess of the limitations specified in any condition contained herein or which otherwise results in, or may possibly be resulting in, noncompliance with the requirements specified in any condition contained herein.
- 9. If a subject source is taken out of operation for a period of one year or more during the term of this operating permit, the permittee shall not thereafter resume operation of the respective source in a manner which is contrary to the requirements specified in Section 127.11a of Chapter 127 of Article III of the Rules and Regulations of the Department of Environmental Protection.
