Clean Air Act Air Toxics Regulations

- CAA Section 112(d) Emission Standards
 - 112(d)(2) requires EPA to set <u>technology-based</u> standards or Maximum Achievable Control Technology (MACT) for industrial source categories
 - 112(d)(6) requires EPA to review and revise (as appropriate) technology standards at least every 8 years
- CAA Section 112(f) Standards to Protect Health and the Environment
 - 112(f)(2) requires EPA to set <u>health-based</u> (Residual Risk) standards within 8 years of promulgation of MACT standard, if necessary to protect public health with an ample margin of safety
- Risk and Technology Review (RTR) EPA combines the initial 112(d)(6) review and 112(f)(2) rulemaking into a single rulemaking package
- CAA Section 112(k) Area Source Program
 - 112(k)(3) National Strategy to identify 30 HAPs which present the greatest threat to public health and source categories accounting for 90% of their emissions



RTR Program Status

- Recently finalized RTRs for Publicly Owned Treatment Works; Nutritional Yeast Manufacturing; and Chemical Recovery Combustion Sources at Kraft, Soda, Sulfite, and Stand-Alone Semichemical Pulp Mills
- Finalized RTRs for about 60 source categories to date
- RTRs required for about 58 additional categories
 - 33 are subject to court orders, 2 are subject to consent decrees, and 9 are subject to ongoing litigation

RTR Program Status (cont.)

- Court orders to finalize RTRs for 33 source categories:
 - 7 final RTRs required by December 31, 2018 (proposals needed by February 2018):
 - Categories currently selected to meet this deadline are: Wood Building Products, Leather Finishing, Fabric Printing (coating), Large Appliances (coating), Metal Furniture (coating), Friction Materials, and Wet-Formed Fiberglass Mat Production
 - 20 final RTRs required by March 13, 2020 (proposals needed by April 2019)
 - 6 final RTRs required by June 30, 2020 (proposals needed by July 2019)
- Consent decrees to finalize RTRs for 2 source categories
 - Completion of Wool Fiberglass technology review required by Dec. 15, 2017 (residual risk review already finalized)
 - Final RTR for Portland Cement due on July 15, 2018



Additional Activity

- Litigating one additional deadline suit covering 9 RTR source categories
 - Awaiting court decision following November 30, 2017 court hearing
- Several RTR reconsiderations underway, including: petroleum refineries, amino-phenolic resins, secondary lead, and off-site waste recovery operations
- Issued an Information Collection Request to the Plywood and Composite Wood Products Industry to obtain data and information to support the upcoming RTR
