# <u>Grant Opportunity: WaterSMART Cooperative Watershed</u> <u>Management Program Phase I</u>

The Department of the Interior, Bureau of Reclamation announced its 2018 funding opportunity seeking proposals for activities to develop a watershed group, fund an existing watershed group, complete watershed restoration planning activities, and design watershed management projects. States, tribes, local and special districts (e.g., irrigation and water districts), local governmental entities, interstate organizations, and non-profit organizations, including existing watershed groups, within the 17 western states are eligible to apply. Up to \$100,000 in federal funds may be awarded to an applicant per award, with no more than \$50,000 made available in a year for a period of up to two years. Applicants must submit their proposals by Wednesday, January 31, 2018, at 4:00 p.m. The funding opportunity number is BOR-DO-18-F005 and the Media Contact is Peter Soeth (303-445-3615).

# <u>S.1057 - Harmful Algal Bloom and Hypoxia Research and Control Amendments Act of 2017 at House of Representatives</u>

On November 16, 2017, the S. 1057 HABHRCA passed the Senate and was introduced to the House Natural Resources Committee to reauthorize and authorize the appropriation of \$22,000,000 in each Fiscal Year over the 2019-2023 period for NOAA to mitigate the harmful effects of algal blooms and hypoxia in marine and freshwater, the Great Lakes, freshwater lakes and rivers, upper reaches of estuaries, and those that migrate to coast waters from freshwater lakes and rivers. The bill would also allow federal disaster-like funds to be used to combat an algal bloom declared to be an "Event of National Significance." Additionally, the bill adds USACE to the Inter-Agency Task Force on Harmful Algal Blooms and Hypoxia. No House committee hearings are yet scheduled.


