



Hillsboro History

- 2015 KMU Pre-Conference Seminar
- Meeting with SEMS CEO Mitch Copman
- Invited Governing Body of Hillsboro and Marion plus staff
- Selecting the department to start

Selecting the department

- Water Department
 - Department head with willingness to try new things
 - Academically prepared
 - Able to teach/assist other departments when it is their turn to start
 - An internal CHAMPION
- Budget issues
 - History of low fund balance
- Auditors asking for inventory data
- What's next?
 - Sewer
 - Electric
 - Streets

Water Department Approach

- Collect Data
- Address distribution first
 - Using Mobile Work Order system
- Plant Maintenance
 - Second step
 - Automatic work order generation
- Budgeted funds for plant and system maintenance repair

Financial Advantage—We were lucky!

- Bond Issue paid off in Water Fund in 2015
- Freed up \$290,000 (\$1,000,000 Budget)
 - Fund Reserve
 - Plant Maintenance
 - Distribution system line replacement
- Governing Body approved a fund balance reserve policy
 - 90 day cash reserves

Implementation of Asset Management Software

- I chose SEMS, Atlanta, Georgia
- KMU, Associate Member

Getting Started

- Started looking at the various water plant systems
- Had to think in "parent/child" relationships with these systems
 - Pump house
 - Filtration
 - Chlorination
 - Distribution
 - Storage
- The parent is the main system and the child is all the equipment making up that system

Data collection phase

- We really didn't understand the parent/child thing at first
- When we started entering data on each piece of equipment we learned that our equipment was older than what we established as the useful life of the equipment.
 - We said pumps had a 20 year life cycle
 - Our pumps had 2X that life
- Caused our Capital Improvement element to have every piece in current year and not spread over a period of years.
 - We had to re-enter data about each piece again to get multi-year planning data
- Water Meter data in our utility billing system wasn't helpful.
 - We had to physically look at each address and check meter number and size
 - Re-entered data in the software

First Win!

- Set up system to generate work orders
- Used mobile devices to communicate with worker in the field.
- Set up a cellular iPad with "DoForms" to communicate with SEMS software
- UB Clerk gets a request for service and creates a request for service
- Field worker gets a text message and email saying there is a new work order
- Field worker opens work order and attends to that work

Second Win

- Started tracking cross connection testing
 - We had an inventory of all the devices
 - When we added a new device in the water system building permit information was shared with the water utility
 - Customers get letters telling them that testing is required and due
 - Compliance data is entered and those who miss the reporting deadline are reminded and to a limited number warned of impending shut-off
