ANNOUNCEMENT OF PUBLIC NOTICE ON THE RESCISSION OF A CLEAN AIR ACT
PREVENTION OF SIGNIFICANT DETERIORATION PRECONSTRUCTION PERMIT
PSD-NM-1644M1

Public Notice Initiated March 7, 2018

The United States Environmental Protection Agency (EPA) is providing notice of its decision to rescind the Prevention of Significant Deterioration (PSD) permit for the Lindrith Compressor Station, Enterprise Field Services LLC [issued to El Paso Field Services]. In 1997, EPA Region 6 issued the PSD permit based on available regulatory requirements for permitting on tribal lands.

The Lindrith Compressor Station (Lindrith) was a major source (>250 tpy) when considering the potential to emit emissions, without controls. However, at the time of its original permit application, the source intended to put controls on two of the three compressor engines in order to become a minor source. Since there were no minor NSR permitting regulations on tribal land available for use at the time of construction, the only permit that could be issued at that time was a major PSD permit for practical enforceability of the engine controls. Lindrith is currently operating under its existing Title V permit R6NM-03-R.

On July 27, 2017, Enterprise Field Services (Enterprise) requested rescission of the PSD permit for the Lindrith Compressor Station, upon EPA's issuance of a synthetic minor permit. EPA promulgated rules for a minor NSR permitting program in Indian Country on July 1, 2011. Further, the EPA's November 2016 rescission regulation allows the EPA to rescind this permit if EPA concludes that the original PSD rule did not apply to the source, and the source continues to be a minor source. EPA recently issued a synthetic minor NSR permit for the Lindrith Compressor Station to Enterprise Field Services on March 7, 2018, under EPA's minor NSR permitting rules and therefore is providing this notice under 40 CFR § 52.21(w)(2)-(3) of its decision to rescind the source's original PSD permit.

Final Determination: Based on the information provided to EPA Region 6, and the EPA records on the Lindrith Compressor Station, EPA concludes that there is sufficient information to support the required rescission elements outlined in 40 CFR § 52.21(w)(2). With the publication of this notice, this PSD NM-1644-M1 PSD permit rescission is effective. This decision can be appealed to the Environmental Appeals Board and is subject to judicial review by the U.S. Court of Appeals for the 10th Circuit.
