### **Program Overview**

- Financial assistance targeted to families with income at or below 80% AMI
- Program targets health and safety hazards in residential housing
- Inspections required to show need for interventions
- Standard federal procurement requirements apply as detailed in 2CFR Part 200

### Program Purpose

- Protect vulnerable residents from housing related health and safety hazards
- Identify and remediate priority housing related health and safety hazards
- Promote cost effective and efficient healthy homes methods
- Public education and outreach
- Build local capacity
- Promote integration with other housing and health programs
- Build partnerships

### **Applicant Eligibility Criteria**

- See NOFA Section III for detailed eligibility information
- Native American tribal governments (Federally recognized)
- Native American tribal organizations (other than Federally recognized tribal governments)
- Eligible applicants are any Indian tribe, band, group, or nation, including Alaska Indians, Aleuts, and Eskimos, and any Alaska native village of the United States which is considered an eligible recipient under Title I of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450) or which had been an eligible recipient under the State and Local Fiscal Assistance Act of 1972 (31 U.S.C. 1221).
  - Selected Conditions of Ineligibility (NOFA has full list)
    - Duplicate applications
    - Individuals are not eligible to apply

### Match Requirements

- 10% Match Requirement
- Source
  - Non-federal with the exception of locally approved Community Development Block Grant (CDBG) funds or Indian Housing Block Grant (IHBG)
- Documentation

#### **Grant Award Amounts**

Total Funding Available \$12,000,000

Maximum Award \$1,000,000

Minimum Award \$500,000

Expecting ~ 12 - 14 awards

36 month Period of Performance

### General Program Info

10 % Administrative Cost Cap

- 65% of the Federal Funds MUST be spent on Direct Healthy Homes Activities
  - Costs are outlined in Section III.E.b

Applicant and Unit Eligibility

## Rating Factor 1 Applicant and Partner Capacity 40 points

#### a. Capacity of the Applicant – 20 points

- Document sufficient staff and organizational experience to facilitate and administer the program
- Document experience and capacity of partners to contribution to the program
- Key Personnel 10 points
- Program Admin Oversight 10 points

## Rating Factor 1 Applicant and Partner Capacity 40 points

- b. Partner Capacity 10 points
- Tribal Epidemiology Center
- Urban Indian Health Program

c. Relevant Organization Experience – 10 points

## Rating Factor 2 Need and Extent of the Problem 30 points

- a. Provide population demographic data of the Target Area = 10 points
- b. Provide data showing age and condition of housing in the Target Area = 10 points
- c. Provide other data which shows the extent of the needs of the population = 10 points

# Rating Factor 3 Program Financial Management 30 points

- a. Submit a budget with estimated costs = 10 points
  - HUD 424 CBW
  - Are your estimates reasonable and appropriate for this type of project?

# Rating Factor 3 Program Financial Management 30 points

- b. Discuss your financing strategy = 10 points
- What type of assistance will you provide to homeowners?
- How will you ensure income eligibility?
- How will you prioritize remediation in units?

# Rating Factor 3 Program Financial Management 30 points

- c. Discuss how you will ensure financial accountability = 10 points
- Who is responsible for fiscal management and accountability?
- How will funds be recaptured if property owners do not comply with program requirements?

- Due Date on or before July 18<sup>th</sup> 11:59:59
- Grants.gov register!
- Waiver of electronic submission
- CFDA # 14.913
- 15 page maximum
- SAM registration
- DUNS Number requirement
