# Solar for Municipal Facilities

## **Cash purchase**

- Need cash up front
- Avoid financing fees
- Tax exempt doesn't capture tax incentives
- Avoids transmission charges
- Your maintenance

## **Power Purchase Agreement**

- No money down
- You pay \$/kwh produced
- Investor can monetize tax credit and share value
- Avoids transmission charges
- Investor's maintenance

## **Community Solar**

- No money down
- You pay \$/kwh at agreed upon volume
- Investor can monetize tax credit
- Have to pay transmission charges
- Investor's maintenance



## Proposals received

- Existing volumetric cost
  - \$0.089/kWh
- Solar Proposals
  - \$0.087/kWh year 1
  - \$0.051/kWh year 1
  - With annual price escalators
  - No distribution fees

- City/Non-profit program w/ competitively selected installer
- Solar Power Hour events
- Limited time bulk pricing that declines with volume


# Leasing Underutilized Property
