OPENING CONFERENCE

The following information was obtained verbally from Mr. Caudle unless otherwise noted.

Company Ownership: Watco purchased this facility from Kinder Morgan on February 1, 2017.

Process Description:

Watco is a public warehouse that stores and handles bulk solid materials, including manganese-bearing alloys (~27% of inventory). The majority of bulk solid materials are received via barge. Manganese-bearing material is weather sensitive and cannot get wet. During barge unloading of manganese-bearing material, only three barge lids are removed at a time.

Bulk material is shipped from Watco via truck. All truck loadout occurs in Building F under one of two dust collector hoods. Building F loadout is equipped with a 60,000 cfm baghouse. The bulk material is transported from its designated bin (which could be in a different warehouse) by a frontend loader to Building F where it is dumped into the truck. The frontend loader operator uses a remote to select the appropriate hood before loading the truck. Once fully loaded, the truck waits under the hood for 30 seconds before driving out of the building.

New high speed doors were installed on Building F. A truck drives up to the entry and the heavy tarp door opens and closes automatically. The doors remain closed during loading. The truck then drives up to the exit and the door opens and closes automatically. Watco also purchased a fogging system for use during barge unloading when the excavator places material into an inplant truck. Watco purchased additional nozzles for additional coverage on the front and back of the truck bed.

TOUR INFORMATION

EPA toured the facility: Yes

Data Collected and Observations:

EPA observed the FRM monitor installed on the roof of the office pursuant to EPA's May 15, 2018 information request. The monitor began operating on September 14, 2018.

EPA also observed the four FEM continuous particulate matter less than 10 microns (PM₁₀) monitors at Watco's facility required by the City of Chicago.

Field Measurements: were not taken during this inspection.

CLOSING CONFERENCE

During the closing conference, Mr. Caudle explained that the street sweeper was recently upgraded with a new internal elevator system. Mr. Caudle also demonstrated how the software that manages the FEM continuous PM_{10} monitors on-site works and explained that Watco has been using the monitors for operational improvements.
