Thank you for the opportunity to respond to the issues and recommendations in the subject Management Alert. Following is the Agency's position on the recommendations. We have provided intended corrective actions and completion dates.

AGENCY'S POSITION AND RESPONSE

We generally agree with the recommendations of the Management Alert as follows:

- Region 5 should update the Cleanups in My Community website and any other relevant websites to correct the status of human health and groundwater migration milestones for the Amphenol site and keep the website(s) current.
- OLEM should remind all regions to verify that the status of human health and
 groundwater migration milestones are accurate and up-to-date on the EPA's websites.
 Specifically, OLEM will remind the regions, per the Agency's RCRA Corrective Action
 Program policy for Duration/Applicability of EI Determinations, that "EI Determinations
 status codes should remain in RCRIS [RCRAInfo] national database only as long as they

remain true (i.e., RCRIS [RCRAInfo] status codes must be changed when the regulatory authorities become aware of contrary information)."1
