Bayer CropScience hereby respectfully petitions EPA to extend the period of exclusive data use for Fluopyram by three years, by applying the provision listed under FIFRA Section 3(c)(1)(F)(ii).

Bayer CropScience believes that Fluopyram meets the criteria required for this provision based on currently registered uses on minor crops including: sweet potato, broccoli, cabbage, cantaloupe, pumpkin, strawberry, peach, cauliflower, cucumber grapefruit, pistachio, watermelon, lemon, tangerine, apricot and sweet cherry, thus qualifying for the maximum of three additional years of data exclusivity. Justification for how Fluopyram meets the criteria requirements are detailed in the enclosed data exclusivity extension petition (MRID #50642501).

We have determined that the proper PRIA code for this submission is M007. An electronic payment in the amount of \$5,250 has been submitted to the Agency through automated clearing house network (ACH). A payment confirmation form is enclosed.
