PUBLIC HEARING FOR PROPOSED CLEAN AIR ACT TITLE V PERMIT

Public Hearing: December 4, 2019 Permit Number R6FOP-NM-2019

As stated in the Public Notice published on October 29, 2019, a Public Hearing relating to the initial proposed Title V operating permit for the Monarch Waste Technologies LLC (Monarch) facility was anticipated in the event that a request was received or if significant public interest was shown regarding the permit action. The United States Environmental Protection Agency (EPA) will hold a Public Hearing from 6:00 – 8:00 pm on December 04, 2019, at the Pojoaque Valley Middle School – Frank B. Lopez Auditorium, located at 1797 State Road 502 West (NM-502), Santa Fe, New Mexico 87506. The purpose of the Public Hearing is to accept oral and written comments into the administrative record. At the Public Hearing, the hearing officer may limit the time available to five minutes or less for each commenter to speak if the hearing officer determines it to be appropriate. We will not respond to comments provided during the Public Hearing. The public comment period has been extended to incorporate all written and oral comments provided at the Public Hearing and will now close on December 4, 2019.

Immediately prior to the Public Hearing, EPA will also hold an informal discussion session to respond to questions on the proposed initial permit and to answer general questions about the permitting process. This informal discussion session will take place at the same place as the Public Hearing, at the Pojoaque Valley Middle School, but will run one hour earlier from 5:00 - 6:00 pm on December 4, 2019. Information shared during this informal session will not be recorded and will not be included in the administrative record for the permit action, since the session is not intended to replace the Public Hearing.
