





Timeline

Equipment Selection and Procurement

- Project budgeted: Late 2016
- RFP for equipment selection: January 2017
- BIOFerm selected as equipment vendor: August 2017
- Design and procurement: Between August 2017 & June 2018
- Installation: Between June 2018 and April 2019
- Completion: April 2019
- Start of O&M: October 2019

• Facility Design and Construction

- RFP for engineering services: June 2017
- Cornerstone selected as engineer facility design: October 2017
- Off-load station added to scope: October 2017
- RFB for construction services: March 2018
- Joe Daniels start of construction: June 2018
- Substantial completion of construction: April 2019



Timeline

Registration and monetization of RNG

- RFP for consulting services: June 2016
- EcoEngineers selected for consulting services: January 2017
- RFP for Monetization and off-take of RNG: June 2018
- Blue Source selected for monetization and off-take of RNG: February 2019

• Pipeline interconnect

- Early engagement with ANR: First quarter 2018
- Contract finalized: September 2018
- Equipment delivery: February 2019
- Commissioning: April 2019
- Ongoing projects
 - Off-load contracting
 - Working out bugs within the off-load station



EPA Pathway Approval


- Metering and monitoring of sources
