WE ALL WANT TO PADDLE AND WE ALL WANT TO STAY HEALTHY. IN THE CURRENT CRISIS, IT MAY BE DIFFICULT TO DO BOTH. IF YOU CHOOSE TO GO PADDLING, HERE ARE SOME HELPFUL TIPS:



If the activities associated with paddling make it impossible for you to respect local orders and national guidelines it's smarter to stay home and stay healthy.

If you feel sick, or have recently been near smeone who is sick - stay home! Contact your doctor for care.

Avoid groups of more than ten people.



MAINTAIN 6 FT OF DISTANCE





Social distancing applies to paddling as well as shuttling. Walk or bike your shuttle route, or consider alternative paddling options that do not require a shuttle, such as park & play or attaining upstream.









MAINTAIN STRICT HYGIENE



Wash your hands often, frequently disinfect gear and other surfaces you touch, and do not share equipment, food, water, or other supplies.



BE CAREFUL

Paddle well below your skill level to reduce risk of injury and potential to find yourself in the hospital and in the proximity of others who are sick.

Don't press your limits - if you need outside assistance, you can put undue strain on local first responders, medical personnel, and increase the risk of exposure for all involved in the rescue.

be considered for funding, the Fund will eliminate the pre-proposal phase in 2020 and request applicants submit a streamlined full proposal. Grant funding in 2020 will be awarded in three categories: Habitat Quality, Green Stormwater Infrastructure, and Public Access

NPS Land & Water Conservation Fund Outdoor Recreation Legacy Partnership

State and local government agencies and federally recognized Indian tribes are invited to submit proposals for matching grants to support projects that would acquire or develop public land for outdoor recreation purposes located within or serving Census-delineated "urbanized areas": places with a population of 50,000 or more people that are densely settled.

*Award range: \$300,000 to \$1,000,000 with 1:1 match

*Applications due: July 10, 2020

2020 National Fish Passage Program

Provides direct technical and financial assistance to partners for activities that restore fish passage and support the modernization of country's infrastructure such as road culverts, bridges and water diversions.

*Award range: \$500 - \$2,000,000 with 1:1 match on a regional basis

*Applications due: September 30, 2020

NPS Rivers, Trails, and Conservation Assistance Program

RTCA is accepting applications for community assistance. National Park Service staff provides free, on-location facilitation and planning expertise.

*Requests considered on a rolling basis through March 2021
