The parties enter into this Clean Air Act Vehicle and Engine Expedited Settlement A eement (Agreement) in order to settle the civil violation(s) discovered as a esult of the inspection(s) specified in Table 1, attached, incorporated into this Agreement by reference. The civil violation(s) that are the subject of this Agreement are described in Table 2, attached, incorporated into the Agreement by eference, regarding the vehicle(s)/engine(s) specified therein.
- 2. Respondent admits the being subject the Clean Air Act (CAA) and its associated regulations and that the United States Environmental Protection Agency (EPA) has jurisdiction over the Respondent and the Respondent's conduct described in able 2. Respondent neither admits nor denies the findings detailed therein, and waives any objections Respondent may have the EPA's jurisdiction.
- 3. Respondent certifies that payment of the penalty has been made in the amount of \$21,686. Respondent has followed the instructions in "CAA Vehicle and Engine Expedited Settlement Agreement Instructions," attached, incorporated into this Agreement by reference. Respondent certifies that the equired remediation, specified in Table 3 and incorporated into this Agreement by reference, has been arried ut.
- 4. By its signature below, the EPA approves the findings resulting from the investigation and alleged violation(s) set forth in Table 1 and Table 2. Upon signing and eturning this Agreement t the EPA, Respondent consents to the terms of this Agreement without further notice. Respondent acknowledges that this Agreement is binding on the parties signing below, and becomes effective on the date of the EPA Delegated Official's ratifying signature.

EPA obtained information, including invoices and sales receipts, for products sold and work performed by Respondent on nonroad vehicles or engines. Based on the information collected, Respondent removed or rendered inoperative emissions control devices or elements of design installed on nonroad vehicles or engines after sale to the ultimate purchaser, in violation of Sections 203(a)(3)(A) and 213(d) of the CAA, 42 U.S.C. §§ 7522(a)(3)(A) and 7547(d), and 40 C.F.R. § 1068.101(b)(1). The information further showed that Respondent sold, offered for sale, or installed parts or components where a principle effect of the part or component is to bypass, defeat, or render inoperative an emissions control device or element of design installed on nonroad vehicles and engines, in violation of Sections 203(a)(3)(B) and 213(d) of the CAA, 42 U.S.C. §§ 7522(a)(3)(B) and 7547(d), and 40 C.F.R. § 1068.101(b)(2), Based on the information summarized below, EPA alleges that Respondent has committed ten (10) violations of the CAA and implementing regulations.

Required Remediation	In addition to paying the monetary penalty, Respondent must cease and refrain from selling or installing any device that defeats, bypasses, or otherwise renders inoperative an emission component of any motor vehicle or engine regulated by the EPA. Respondent must cease and refrain from tampering with emission control systems on EPA-certified motor vehicles and engines and nonroad engines. Respondent is aware of EPA's November 23, 2020 "Tampering Policy: The EPA Enforcement Policy on Vehicle and Engine Tampering and Aftermarket Defeat Devices under the Clean Air Act."
