NATIONAL WATER REUSE ACTION PLAN COMPLETED ACTION

Action 1.1 Develop a Federal Policy Statement to Support and Encourage Consideration of Water Reuse in a Watershed-Scale Planning Context



Background

National water programs are implemented throughout many different federal agencies and departments. Many stakeholders have expressed that the lack of a unified and coherent federal policy supporting water reuse remains a barrier to fully leveraging federal resources (technical and financial) in support of water reuse.

A federal water reuse policy statement can encourage innovative water management approaches through the reuse of municipal wastewater, stormwater agricultural return flows, stormwater, and some industrial wastewaters for different potable and non-potable purposes. Water reuse on a watershed/basin level may reduce demand for conventional potable water sources and provide other ecological and financial benefits.

Accomplishments

The National Water Reuse Action Plan (version 1) presents a federal policy statement in support of water reuse:

"Water is critical to our nation's health, strength, security, and resilience, but the solutions available to manage water and its availability are often complex. When incorporated into an integrated water management plan, water reuse can be a valuable tool to enhance the availability and effective use of water resources. The federal government recognizes, acknowledges, and respects the primacy of states in the management of water resources within their borders.

The federal government supports the consideration of water reuse to increase water security, sustainability, and resilience, especially when considered through integrated and collaborative water resource planning approaches, typically at the watershed or basin-scale."



Stakeholder engagement in the development of the WRAP

The policy statement is intended to encourage the consideration of water reuse and integrated watershed-scale planning approaches; communicate the value and benefits of water reuse; and leverage existing programmatic, funding, and technical resources.

Action Impact

This policy statement signals federal support for water reuse and encourages water resources managers to consider water reuse as a tool during planning efforts at local, basin, and/or regional scales. It also communicates the importance of integrated water resources management planning approaches.

This policy statement also helps to strengthen collaboration across federal agencies by affirming unified support for the consideration of water reuse. More than 15 federal agencies are actively involved in supporting WRAP actions. WRAP actions with federal partners serving as part of the action teams include:

Action Implementation Process

Stakeholder input received through extensive outreach and public comments during the Action Plan development process expressed that a unified federal policy statement would allow for communities, policymakers, water resource planners and practitioners to better leverage federal resources in support of water reuse. In response to public input and through regular coordination with federal partners, EPA's Water Reuse Team developed the federal policy statement on reuse that was then issued in February 2020.

Future Activity

The policy statement supporting consideration of water reuse provides a foundation for continued collaboration across federal agencies. Furthermore, it reinforces federal agency commitments to support the WRAP effort and implement the applicable WRAP actions. As described in Action 2.7, the WRAP Federal Partners work group will continue to convene to continue and strengthen collaboration while reviewing progress on water reuse actions.
