Question: What is the timeline for projects?

Answer: Successful applicants will be notified in early July 2021 and unsuccessful projects will be notified

by mid-July 2021. Projects under this RFA are to begin October 1st, 2021 and will be for one year.

Question: Can you provide examples of past projects?

Question: Will grants for multistate or regional efforts be viewed more favorably? Answer: Please refer to the FY21 SMM priorities as part of this RFA. Depending on how your project responds to the RFA it may or may not be an element.

Question: How should the food recovery rescue and source reduction elements in Priority #2 Strategies for Preventing Food Loss and Waste Through Source Reduction and/or Food Rescue in Region 5 be addressed as other organizations do similar work in food loss and waste?

Answer: EPA is requesting applications for projects that use the top two strategies, of the Food Waste Hierarchy (Source Reduction and Feeding Hungry People) either individually or in a combination, to prevent food loss and waste. Projects submitted under this RFA will work with a network of stakeholders to achieve this goal and demonstrate progress to reaching EPA's 2030

Food Loss and Waste Reduction goal. As part of the project, applicants must also ultimately submit projects that achieve these goals and the goals of the EPA Strategic Plan and the Solid Waste Disposal Act Statutory Authority referred to in the RFA.
