UPCOMING EPA ENGAGEMENT OPPORTUNITIES

Oil and Natural Gas Methane Proposed Rule

EPA is taking the first step to develop a proposed rule to reduce methane and other harmful pollutants from new and existing sources in the oil and natural gas industry, beginning with a broad public outreach effort to gather community and stakeholder input. These activities include holding training sessions on the rulemaking process and how to participate in it, convening listening sessions for stakeholders, and opening a public docket for pre-proposal comments.

Applicants interested in either funding opportunity must submit grant proposal packages by **June 1**, **2021** to be considered for the available funding. Applicants should plan for projects to begin on October 1, 2021.
