UPDATE: A FIRE WAS REPORTED AT BIO-LABS, INC. IN CONYERS, GA. THE BUILDING INVOLVED IN THE FIRE WAS REPORTED TO CONTAIN POOL CHEMICALS AND OXIDIZERS. EVACUATIONS WERE ESTABLISHED IN THE IMMEDIATE AREA AROUND THE FIRE. ADDITIONALLY, SECTIONS OF INTERSTATE 20 WERE CLOSED AT TIMES DURING THE IITIAL FIRE. OSC FRANCO AND OSC RICK JARDINE WER DISPATCHED TO ASSIST EPD, GEMA, AND LOCAL OFFICIALS. UPDATE: 5-26-04 EPA ERRB STAFF CONTINUES TO PROVIDE OVERSIGHT AND ASSISTANCE IN RESPONDING TO THE BIO-LABS, INC., CHEMICAL WAREHOUSE FIRE IN CONYERS GEORGIA. THE BUILDING INVOLVED IN THE FIRE WHICH SERVED AS A DISTRIBUTION CENTER FOR POOL CHEMICALS AND OXIDIZERS FOR RETAIL SALE IGNITED SOMETIME AROUND 0400 A.M., ON MAY 25TH. THE RESULTING FIRE PRODUCED A TEN MILE PLUME OF SMOKE THAT BLANKETED AREA BUSINESSES, RESIDENTIAL NEIGHBORHOODS AND A LARGE PORTION OF I-20. SEVERAL PERSONS WERE ADMITTED TO LOCAL HOSPITALS AND TRAFFIC WAS DETOURED TC ALTERNATE ROUTES FAR AWAY FROM THE IMPACTED AREA. OSC FRANCO AND JARDINE WERE DISPATCHED TO ASSIST EPD, GEMA, AND LOCAL OFFICIALS. OS BRYD ALSO WAS MOBILIZED TO THE SCENE TO PROVIDE ASSISTANCE WITH AIR MONITORING AND PLUME TRACKING. OSCS SPURLIN, BASS AND FEINGOLD WERE DISPATCHED AT 0300 THIS MORNING TO RELIEVE THE THREE INITIAL RESPONDING OSCS. THE U.S. COAST GUARD GULF STRIKE TEAM (GST) WAS MOBILIZED FROM MOBILE, ALABAMA TO PROVIDE ADDITIONAL AIR MONITORING

AND SITE SAFETY. THE NATIONAL ATMOSPHERIC RELEASE ADVISORY CENTER (NARAC) PROVIDED THE EPA TEAMS WITH HOURLY PLUME MODELING BASED ON ATMOSPHERIC WEATHER PATTERNS. GROUND ANALYTICAL DATA WAS USED TO DEVELOP ADDITIONAL PLUME MODELING. ADDITIONALLY, AN EPA DISASTER FIRST-RESPONDER CREW BROUGHT IN A AEROCOMMANDER 680 AIRCRAFT EQUIPPE WITH THE AIRBORNE SPECTRAL PHOTOMETRIC COLLECTION TECHNOLOGY (ASPECT TO PROVIDE GROUND TEAMS WITH SURVEILLANCE AND TIMELY DATA OF POTENTIAL CHEMICAL RELEASES FROM THE PLUME. LOCAL FIREFIGHTING ACTIVITIES AND DEMOLITION OF THE PORTIONS OF THE WAREHOUSE CONSUMED BY THE FIRE HAVE REDUCED THE PLUME. THE I-20 CLOSURES HAVE BEEN LIFTED AND MOST OF THE SURROUNDING COMMUNITY MAY BE ALLOWED BACK INTO THEIR RESPECTIVE HOMES AND BUSINESSES BY THE END OF THE DAY. THE EPA TEAMS ON-SITE (EPA, START AND THE GST) CONTINUE TO COLLECT AIR MONITORING DATA USING SINGLE POINT MONITORS. MOST OF THE SAMPLING DATA COLLECTED OUTSIDE OF THE INITIAL EVACUATION AREA SHOWS CONCENTRATIONS WELL BELOW ESTABLISHED HEALTH-BASED LEVELS OF CONCERN EPA'S AIR MONITORING EFFORTS TODAY WILL FOCUS ON THE AREA STILL EVACUATED BORDERED BY I-20, GEORGIA 138 AND SIGMON ROAD. AIR QUALITY DATA IS BEING TRANSMITTED TO THE UNIFIED COMMAND ON-SCENE. EVACUATION DECISIONS ARE BEING MADE BY THE ROCKDALE COUNTY SHERIFF IN CONSULTATION WITH PUBLIC HEALTH OFFICIALS. THE RESPONSIBLE PARTY CONTINUES TO ADDRESS THE RUN-OFF FROM THE FIRE WHICH HAS CAUSED LOW PH LEVELS IN LAKES ADJACENT TO THE COMPLEX (WALKER AND VFW LAKES). GEORGIA EPD STAFF IS MONITORING RP EFFORTS AND CONDUCTING AN INTENSIVE SEARCH OF ADJACENT WATER-BODIES/TRIBUTARIES. SODIUM BICARBONATE IS BEING INTRODUCED INTO THE WATER TO MODIFY THE PH. FISHERIES KILLS HAVE BEEN REPORTED IN THE OUTFALL FOR VFW LAKE, TANYARD BRANCH AND ALMAND CREEK. A REPRESENTATIVE FROM THE U.S. FISH AND WILDLIFE SERVICE HAS BEEN NOTIFIED. UPDATE: 5-27-04 - ROCKDALE COUNTY HAS LIFTED THE EVACUATION FOR ALL RESIDENTIAL AND COMMERCIAL PROPERTIES EXCEPT THOSE IMMEDIATELY ADJACENT TO THE FACILITY. CONTAMINATION OF SURFACE WATER STREAMS AND PONDS BY FIREFIGHTING RUN-OFFS IS SIGNIFICANT AND HAS CONTRIBUTED TO A SUBSTANTIAL FISH KILL IN VFW LAKE AND SEVERAL OTHER TRIBUTARIES. GA EPD CONTINUES TO DIRECT ACTIVITIES ASSOCIATED WITH THE AFFECTED WATER-BODIES. EPA ERRB STAFF WILL CONTINUE TO SUPPORT THE OPERATION WITH AIR MONITORING BECAUSE CHLORINE OFF-GASING FROM THE WATER IS IRRITATING TO THE RESPONDERS. THE U.S. COAST GUARD, GULF STRIKE TEAM AND THE ASPECT AIRCRAFT AND CREW HAVE DEMOVED FROM THE RESPONSE.
