Dear Administrator Johnson:

I write on behalf of petitioners St. Bernard Citizens for Environmental Quality and Louisiana Bucket Brigade who hereby withdraw petitions they filed pursuant to section 505(b)(2) of the Clean Air Act. Petitioners withdraw their petitions because they resolved matters cooperatively through settlement with facility owner and operator Chalmette Refining, LLC.
