## **MEMORANDUM**

SUBJECT: Project Notification: Evaluate EPA's Progress Under Plan EJ 2014 (Project No. OPE-FY14-0040)

The U.S. Environmental Protection Agency's (EPA's) Office of Inspector General (OIG) is starting preliminary research on the EPA's oversight of environmental justice activities. The OIG's preliminary research objectives are to determine:

- 1. Why EPA has not yet finalized the *Interim Guidance on Considering Environmental Justice During the Development of an Action* (dated July 2010), as required by Plan EJ 2014 (dated September 2011).
- 2. The impact upon the rulemaking process as a result of the *Interim Guidance* not being finalized.
- 3. The extent to which the EPA has adhered to the *Interim Guidance* and can show measurable results.

This project is included in the OIG's fiscal year 2014 Annual Plan.

The purpose of this memorandum is to confirm our mutual understanding on the objective and scope for the evaluation, and the responsibilities of the Office for Enforcement and Compliance Assurance and the OIG during the project. We plan to contact the lead program offices and regions responsible for incorporating environmental justice in rulemaking. Specifically, they include:

- Office of Chemical Safety and Pollution Prevention.
- Office of Policy.
- Office of Research and Development.
- Office of Environmental Justice.
- Region 9.

As appropriate, we may contact additional stakeholders. We will conduct the project using applicable *Generally Accepted Government Auditing Standards*.

We will contact you through your Audit Follow-Up Coordinator to arrange a mutually agreeable time to meet and discuss our objectives, the purpose of the preliminary research phase of our project and any areas of concern that you may have. We will answer any questions you or your designee(s) may have about the project process, reporting procedures, methods used to gather and analyze data, and what we should expect of each other during the course of the project. We will provide updates on a regular basis to agreed-upon contacts.
