The U.S. Environmental Protection Agency (EPA) Office of Inspector General (OIG) plans to begin the preliminary research phase of an audit evaluating Region 7's monitoring for compliance under its Superfund Technical Assessment and Response Team (START) contract (EPS71306). The objectives of our audit are to determine whether:

- 1. The EPA is monitoring the contractor for compliance with the terms and conditions of the contract.
- 2. The costs billed are in accordance with the contract terms and condition.

- A copy of the base contract.
- An updated listing of the contract's task order managers (if applicable), contracting officer's representatives, and project officers assigned to the base and subsequent task orders.
- Any pre-award reviews conducted prior to awarding the contract.
- The indirect cost rate agreement(s) between the contractor and the EPA for the effective period of the contract.
